



I hope this message finds you well and in good spirits! Every two years those of us in office who plan to seek re-election say goodbye and make a final report before the Local's biennial General Election. While these reports can be one of the




highlights of our monthly tasks, knowing that the occasional writers block will be averted is a welcoming thought. As this will be my last communication to you for 2018, I believe a recap of the accomplishments of this administration over the last several years is in order.




We began in 2015 putting forth a bold vision to transform

our union. That vision, which required your approval to sell our aging property in Hollywood and relocate, allowed us to revitalize our union by moving us to a new modern facility and create an endowment to help stabilize our union's finances. Over 80% of our membership voted in the affirmative, and within two years we identified a property, renovated it and relocated to an exciting location in Burbank, while in the process establishing a \$4 million endowment, growing our coffers by over 400%! Our new facility, comprised of seven state-of—the-art rehearsal studios, a beautiful Artists' Lounge, the SAG-AFTRA Federal Credit Union, and new business offices, have raised the profile of Local 47 within our music community and throughout the Federation.



our leadership and membership in an effort to create a clear plan that charts out a path toward continued modernization and growth. The Strategic Plan, adopted unanimously by our membership, is now being implemented through an institutional-wide process. These last two years we concluded negotiations for some of our most important and key CBAs, achieving groundbreaking deals with the Los Angeles Philharmonic, Los Angeles Opera, Pasadena Symphony, Los Angeles Master Chorale, and Pantages Theatre, just to name a few. We are proud to have raised the bar throughout the U.S. and Canada establishing that our LA Phil musicians are now one of the highest paid orchestras in North America. In all of these negotiations not only have we made significant improvements to the contracts, we have also raised the bar in our approach to bargaining by building strong committees, which delivered improved results. During the last two years we reached a historic agreement for musical engagements performed at the soon-to-be built Clippers venue, having already reached first-time deals to cover musical engagements at new venues for the Chargers and Rams. Also, after almost two decades of fighting for meaningful legislation in Sacramento to create effective music-scoring provisions under the California Film & Television Tax Credit Program, in 2018 we achieved a landmark win with the help of Assemblymember Ian Calderon when AB 1734 was adopted by the legislature making music scoring a key component of this new law providing bonus points to productions that agree to score in CA and making music jobs a key part of every application for the tax credit.

This year we announced a first-time CBA for work at the Wallis Annenberg Center for the Performing Arts, establishing that all musicians performing at this new venue in Beverly Hills will be covered under a union contract. Also this year we launched a pilot program in partnership with the Glendale and Burbank School Districts creating the Local 47 Career Pathways Program,

bringing high school students onto the scoring stage and offering opportunities for early career exposure and mentorship opportunities while at the same time creating employment for our members who participate in these programs, all funded by state and federal grants.

These past two years together we have achieved many firsts,

and while we have made significant progress there is still much,

much more that needs to be done. As we enter the last part

of 2018, let's keep working together, supporting each other,

and continuing to keep our union on a path of growth, forward

progress and success!

I love my job as Vice President. I love that I can speak to our new members who have just joined the union. After orientation day, I invite them into my office and we discuss their dreams and their



questions about how to get started in the Los Angeles music scene. When they enter my office I always ask my first question: "May I have your business card?" I am amazed at how many of these musicians do not have a business card. I remind them of how it is by far the cheapest way to advertise what you do and more importantly, how to get a hold of you for work. I usually get the blank stares and then I bring up just one scenario. You are playing somewhere — could be at church, at a dance or showcase or even just practicing — and a stranger comes up to you and says, "Hi, I am a composer/contractor and I think you sound terrific. What is your name, and how do I get ahold of you for gig I have coming up?" "Sorry, I do not have a card, but I can write my info on a napkin." WRONG!!!

Then I tell them of my experience on a gig. I was playing a casual with the Manny Harmon Orchestra at the Beverly Hilton Hotel. I stood up and played a few solos during the night, and while I was packing up at the end of the evening an older gentleman came up to me and asked for my card. He said he loved my sound and my playing. I gave it to him and he told me he was going to give it to his contractor Charlie Price, who would be contacting me for work. That gentleman was David Rose, and I indeed got a call the next week from Charlie to show up at MGM studios to work on a TV show. That call led to me working with David for three years.



My other favorite thing to do as Vice President is speak at various high schools and colleges throughout L.A. I try to line up about 12 to 13 different schools every year. The classes range from instrumentalist to music composition studies, and even music business courses. I first start out by talking about my career in the studios and then take questions about our union. I find it very interesting that when they ask their questions the first one is usually, "Does the union get me work?" I explain that we have a referral service called Gig Junction, and that when you join you are open to use this service to help find work. I also educate them on how to connect with the top players in the studio. I urge them to call those musicians and simply ask to take a lesson from them. By doing so, the musician will not only be heard during the lesson, but more importantly they will show their personality and sometimes that is most important in securing a job. I have seen many a young player in the studios who did just that and their careers got started from a lesson, when a phone call was made by the teacher to a composer/ contractor or even another player to use them as a sub. Many careers have started out by subbing and being heard by other musicians.

Finally, two years ago, the great Bob Bain called me up to say that he loves reading my column every month and for me to always keep it interesting and informative for our fellow musicians. I have just returned from his Celebration of Life memorial service at the Sportsmen's Lodge where over 200 musicians and family payed tribute to this great man. Bob, you will never know how much your words meant to me. RIP dear Bob.





experience. One network that has been delivering on this and employing many musicians from Local 47 and AFM is ABC Studios. "Once Upon A Time" has been doing exactly that for seven seasons, over 156 episodes. The series ended this year with a happy ending for the music. Oscar-winning composers Mark Isham, along

with Cindy O'Connor and Michael Simon, received an Emmy nomination for Outstanding Music Composition for a Series for their work on the episode "Leaving Storybrooke."



"Once Upon A Time" positions classic fairy tale icons like Snow

White and Rumpelstiltskin in our contemporary world, and mu-

sic performs a vital role in adding the mystical, magical atmo-

sphere that allows these fanciful characters to operate alongside automobiles and smartphones. Whether it's accompanying a trio of burly elves whistling while they (prepare to) work, providing a doom-laden mood while Rumpelstiltskin alter ego Weaver (Robert Carslysle) talks about being stripped of his immortality, or just creating a classic happy ending, the show's orchestral scoring adds a movie-sized emotional scale to the small screen. Lead composer Mark Isham is no stranger to awards — he won an Emmy for his theme music to "EZ Streets" and has been nominated for both the Oscar and Golden Globe — but for him,

'Once Upon A Time,'" the composer said. "I share this with my wonderful composing collaborators Cindy O'Connor and Michael Simon. A huge shout out to ABC Studios for their terrific support over our seven-year run, supporting us in maintaining the musical quality of the show by recording weekly with a live orchestra right here in Los Angeles. Cindy O'Connor, a longtime member of the musicians union, has become part of a growing wave of female composers finally earning recognition and credit in a field that has been largely dominated by men. She is also the only female composer nominated in the scoring categories this year. O'Connor cites the scoring team's work with Los Angeles's legendary scoring session players as one of the luxuries of working on "Once Upon A

"We've been so fortunate to work with L.A. union orchestras the best players in the world — since the very beginning of the show," she said. "Dawn Soler, ABC's Music Chief, is a great advocate for scoring with live musicians, and the showrunners Adam Horowitz and Eddy Kitsis really appreciate the emotional power that an orchestra brings to a score." Recording live players for complex, nuanced orchestral music week in and week out requires players who are at the abso-

lute top of their game, which is what Isham, O'Connor and Si-

"You should see their faces when we say, 'None! They're seeing the music for the first time right now.' The sight-reading ability of L.A. players is off the charts. And they're not only playing all the notes correctly but playing with emotion and musicality right from the first take." Additionally, Michael Simon — also a proud member of the union — praised the players for bringing the final, magical touch to the three composers' music. "It was never lost on me how much of a gift it was to be able to have your music played week

after week by musicians who are at the top of their field," he

said. "Whether it was a lively pirate-y solo played by Julie Gi-

gante, an earnest and haunting alto-flute solo by Chris Bleth, or

the soaring magical voice of the ensemble as we guided the story through its epic highs and lows, we always left our sessions feeling a profoundly elevated sense of accomplishment due to the performances." "The level of integrity that a live orchestra brings to a project is unparalleled, and we are thrilled that this year's Emmy voters recognize this," said AFM Local 47 President John Acosta. "From the composers, music prep personnel and performing musicians

who brought this music to life, everyone involved is deserving of this honor." The score album for the final episode "Leaving Storybrooke" is available from Walt Disney Records.



There are many other important political issues at this time. But artists' rights are the workers' rights of musicians and other creative workers. The fight to hold Silicon Valley accountability for their other destructive corporate behaviors is our part of the fight to hold these corporations accountable for their destructive behaviors... and protect our livelihoods in the process.

During the past year, rank-and-file musicians in AFM Local 802's Artist Rights Caucus (ARC 802) have been educating union members, supporting pro-artist legislation, and building towards a campaign to restore economic justice in the digital domain. Our problem isn't digital technology itself — which most of us use, support, and value — but the unfair loopholes in the law which permit major online corporations to profit from mass infringement of our rights with impunity.

The AFM is already signatory to excellent policy which would put a stop to this. (See the AFM/Music Community Response to the US Copyright Offices Inquiry on Section 512 of the DMCA.) If enacted, it would restore a fair market for our work...and help musicians across the board.

But this isn't going to happen without all of us showing our support by joining an Artist Rights Caucus.

Policy Governing Eligibility to Vote in the Dec. 11, 2018 **Local 47 General Election**

- 1. All Local 47 members who are in good standing as of 4 p.m. (close of business) on Monday, Dec. 10, 2018 — the last business day prior to the 2018 General Election — are eligible to cast a ballot.
- 2. Any Local 47 member who has been suspended or expelled for the non-payment of dues or wishing to reinstate within one year of resignation shall have until 4 p.m. (close of business) on Monday, Dec. 10, 2018 by which to clear his/her delinquency and return to full good-standing status in order to be eligible to cast a ballot.

3. New members or those rejoining after resignation must complete

and submit a membership application no later than Monday, Dec. 3, 2018, so that their membership can be approved at the next Local 47 Executive Board meeting on Tuesday, Dec. 4, 2018. All applicable fees apply. Note: the Local reserves the right to refer applications of all persons seeking reinstatement from resignation to the International Executive Board per Article 9, Section 19 of the Federation's Bylaws.

4. Life Members who hold Inactive status do not have the right to

vote in any Local 47 election. Active Life Members may vote. Inactive Life Members wishing to be restored to full Life Member status may do so by submitting payment of the difference between full Life Membership Periodic Dues and Inactive Life Membership Periodic Dues for the year. For those who wish to cast their vote in the 2018 General Election, the difference owed would be \$20 and must be paid by 4 p.m. on Monday, Dec. 10, 2018.







Hollywood Bowl Recognized for Environmental Excellence

"The Hollywood Bowl has shown a strong commitment to its environmental program," said Christine Kane, Executive Director at Audubon International. "They are to be commended for their efforts to provide a sanctuary for wildlife. The Audubon Cooperative Sanctuary Program benefits both people and wildlife. It's a great way for businesses and environmental organizations to work together to become better stewards of the land and natural resources."

By participating in the ACSP, the Hollywood Bowl has been involved in projects that enhance habitat for wildlife and preserve natural resources for the benefit of the local community. These projects include conserving energy and reducing waste, utilizing integrated pest management techniques, naturalizing areas, and managing resources in an environmentally responsible manner.



Neil Argo Member. Composer 5/28/1947 - 8/2/2018

Composer and orchestrator on Aaron Spelling dramas dies at 71



Neil Argo, a composer and orchestrator who worked on such shows as "Dynasty," "Beverly Hills 90210" and the long-running nature documentary series "Wild America," has died. He was 71.

Argo died Aug. 2 of heart failure at the Mayo Clinic in Scottsdale, Arizona, talent manager Otto Vavrin II announced.

Argo also did music for "Melrose Place," "The Colbys," "Hotel," "Burke's Law" and "Hearts Are Wild" — like "Dynasty" and "90210," shows from Aaron Spelling's production company — as well as for a new version of "Mission: Impossible" and "Mac-Gyver."

Argo scored the theme, as well as over 100 episodes, of "Wild America," which aired from 1982-94 on PBS.

"Neil had the ability to cut to the core of a scene in a surprising and touching way," friend and "Wild America" producer Marty Stouffer said in a statement. "And he could express universal emotions that we really hadn't picked up on as yet."

Argo was the composer on the 1993 Emmy-winning National Geographic special "Survivors of the Skeleton Coast" and the recipient of 15 Telly Awards for his work in advertising.

His film work included "P.J." (2008), starring John Heard, and "Chasing the Green" (2009).

Argo received his bachelor's degree in music from North Texas State University and his master's from the University of Northern Colorado.

Survivors include his wife, Zenna.

Thomas Stevens was appointed to the Los Angeles Philharmonic in 1965 by then-Music Director Zubin



Mehta, who named him principal trumpet in 1972, a position he held until 2000. He served in the same capacity with the World Orchestra for Peace, Sir George Solti's hand-picked group assembled in Geneva for the celebration of the 50th anniversary of the United Nations, and the Casals Festival Orchestra in Puerto Rico.

The Los Angeles appointment was preceded by a stint in the U.S. Army as solo trumpeter with the West Point Band, followed by a one-year engagement with the Dallas Symphony Orchestra.

In addition to his work as an orchestral musician, Stevens performed and recorded as a soloist and chamber musician with major organizations worldwide, including the Chamber Music Society of Lincoln Center, and in the early 1980s he was invited by Pierre Boulez to participate in a special new brass music project with the Ensemble InterContemporain in Paris. He was a founding member of the Los Angeles Brass Quintet and also maintained an active presence in the Hollywood recording studios for many years.

Stevens is perhaps best known for his activities in the promotion, performance, and premiere recordings of new music for solo trumpet. His efforts resulted in many works which have become staples of the genre, including Sequenza X by Luciano Berio, which was written specifically for him.

Stevens was a published composer, arranger, and orchestrator whose works have been performed in major concert venues and on recordings. His original educational materials are used in music schools throughout the world. He was the editor of the definitive published version of the internationally acclaimed James Stamp Warm-Ups and Studies (Editions Bim) and also edited the James Stamp Supplemental Studies (2009) for the same publisher. In 2011, Stevens compiled and edited the Editions Bim publication After Schlossberg, a collection of derivative post-Schlossberg era trumpet studies, and in 2016, Gossamer Wings Music released the educational video Thomas Stevens on Musicianship: Vacchiano's Rules and Beyond, which features selected excerpts from Stevens' masterclasses at the Center for Advanced Musical Studies at Chosen Vale in New Hampshire. In 2017, the hour-long video Thomas Stevens, The Schlossberg Workshop at Chosen Vale was posted on YouTube.

Thomas Stevens' primary trumpet studies were with Lester Remsen and James Stamp in Los Angeles and William Vacchiano in New York City. As a teacher in his own right, Stevens was a regular faculty member at the University of Southern California, CalArts, and the Music Academy of the West and gave master-classes and held residencies at leading institutions around the globe. The list of those who have studied with him includes prominent international soloists, members of major symphony orchestras, and faculty members at leading universities and schools of music. Stevens was a member of the founding board of directors of the International Trumpet Guild.

Following his retirement from the Los Angeles Philharmonic in December 1999, Stevens continued his activities on the international masterclass circuit, teaching in various U.S. and European venues, including repeat appointments to the faculties of the Lake Placid Institute, the Center for Advanced Musical Studies at Chosen Vale, TAW Bremen, Germany, and, during the fall term of 2008, the California Institute of the Arts.

In 1996, Stevens was named outstanding alumnus of the year by the University of Southern California Thornton School of Music, where he did his undergraduate studies, and in 2007 he received

a Certificate of Special Recognition from the Congress of the

United States, together with a similar citation from the California

State Senate, for "outstanding and invaluable service to the community."


Patrick Williams

Life Member. Composer 4/23/1939 – 7/25/2018

Patrick Williams, the Emmy- and Grammy-winning and Oscar-nominated composer-arranger-conductor, died of complications from cancer July 25 in Santa Monica, Calif. He was 79.

Williams, known to friends and fellow musicians as "Pat," was a highly respected and beloved figure in both New York



and Hollywood musical circles. His jazz albums earned 19 Grammy nominations (winning twice) and his television scores earned a total of 22 Emmy nominations (winning four times).

Williams was nominated for a 1979 Oscar for "Breaking Away," one of his nearly 50 movie scores that also included "Casey's Shadow," "Cuba," "Used Cars," "Swing Shift," "All of Me," "Cry-Baby," "The Grass Harp" and "That Old Feeling."

Tens of millions heard Williams' classy, fun scores every week throughout the 1970s and '80s for such series as "The Mary Tyler Moore Show," "The Bob Newhart Show" and "The Days and Nights of Molly Dodd," along with his more dramatic music for "The Streets of San Francisco," "Columbo" and "Lou Grant." He scored dozens of TV-movies and miniseries including such acclaimed telefilms as "Decoration Day," "Geronimo" and "Kingfish: A Story of Huey P. Long" and the multi-part "Jewels," "Jesus," "Blonde," "Solomon" and "Hercules."

But it was in the jazz world that Pat Williams had the most fun. His big-band LPs and CDs, which included the widely acclaimed, Grammy-winning 1973 "Threshold"; his arrangements for Tom Scott, Bill Watrous and his L.A. band on the Soundwings label of the 1980s; and his more recent swingfests including "Sinatraland," "Aurora" and "Home Suite Home" are among the most admired and appreciated jazz albums of their time.

Williams' arranging talents were also much in demand by lead-

ing singers including Barbra Streisand, Jack Jones, Natalie Cole, Neil Diamond, Gloria Estefan, Michael Feinstein, Vince Gill, Amy Grant, Patti Austin, Monica Mancini and Bette Midler. Among the most prestigious of these assignments were Frank Sinatra's two best-selling "Duets" albums in 1993-94.

The composer's large-scale orchestral works weren't as well

known to the public but were equally stellar, musically, including his Pulitzer Prize-nominated "An American Concerto" for jazz quartet and symphony orchestra in 1976; his tone poem, "Gulliver," with text by Larry Gelbart and narration by Sir John Gielgud in 1986; and a "Concerto in Swing" for clarinetist Eddie Daniels in 2000. Critic Gene Lees once said "Pat's writing is breathtaking. He's just one of the finest arrangers and composers who ever put pen to paper."

He was born Patrick Moody Williams on April 23, 1939, in Bonne

Terre, Mo., and moved to Connecticut when he was 10. He studied at Duke University; in 2001 his alma mater awarded him an honorary doctorate in fine arts.

Williams became a sought-after arranger and commercial-jingle composer in New York during the 1960s. He moved to L.A. in 1968 to seek work in film and TV and found immediate and last-

Missouri Overwhelmingly Rejects 'Right to Work' in a Big Win for Unions

Last month was historic for working people in Missouri. Wealthy corporate interests tried to use their money to rig the system in favor of the 1%. But Missourians rejected the cynical power grab by an overwhelming 2-1 majority.

From statehouses and city councils to the halls of Congress, working people are fighting back, and this November, we will elect our allies and retire our enemies. 


