



Officer Reports

President John Acosta

As we celebrate Black History Month I want to acknowledge the LA Jazz Society for their work in public schools, which is front and center this month in its Jazz in Schools outreach program co-



sponsored by Local 47's Music Performance Trust Fund (MPTF). Every year, with the help from our Assistant to the President Diane Lauerman, the LA Jazz Society brings live music to hundreds of students around the southern California area. Without support from MPTF, programs like this would not be possible.

As 2019 kicks into full gear, so do we here at Local 47. Several negotiations have already begun with a variety of employers. We are currently in talks with managements from the Greek Theatre, MET/Community Orchestras, LA Jazz Society, and Palm Springs Opera Guild. We recently concluded negotiations with LA Ballet, El Portal, El Capitan and Musical Theatre Guild. I want to thank our VP Baptist and Secretary/Treasurer Lasley for their assistance in bargaining these agreements. I also want to acknowledge our staff for their administrative support getting these contracts completed.

I would also like to highlight the priorities for this administration. This will be a busy year for us as we host the 2019 Western Conference of AFM Locals. The Western Conference takes place every year in a different city, bringing together AFM leaders from dozens of Locals across the country. The conference also provides a space for our national leadership to report on AFM national business. We are planning to have a very informative conference with panels and workshops presented by some of L.A.'s finest.

Also, this year we continue the implementation of the Local 47 Strategic Plan which was adopted in 2017 with several offshoot committees meeting to further develop the plans goals and initiatives. This year we look to expand our work in promoting diversity and mentorship at the Local and in the workplace. We have already discussed partnerships with a variety of our employer partners and I am looking forward to seeing more in the way of outreach within and without our union. The Local 47 Executive Board has established a Local 47 Multipurpose Space Phase 2 Committee to probe the possibilities of public/ private partnerships to develop a multipurpose space adjacent to our main building.

Every job you do as a musician should and can be on an AFM contract – from your church gig or demo recording to your wedding reception; from your nightclub gig to your weekend corporate event. An AFM contract guarantees that your wages will be paid, you receive contributions to your pension and health plan, and that the terms and conditions of your gig are clearly spelled out. The duty to file a contract is incumbent on all members, and starts with your leadership, emanating from the Local 47 Executive Board and on to the membership at large. Whether it's a live performance or a recording gig, make sure you check with our staff to see which contract is best for the type of work you're doing. The Local 47 staff are the greatest resource for members who are navigating how to get their jobs on contract. We are here for you, so do not hesitate

in reaching out when you are seeking guidance on how to file a contract.



Awards Season

I always get very melancholy at this time of the year, Awards show season. This is when our musicians have a chance to work



on the Golden Globes, Critics Choice Awards, SAG Awards, the Grammys, Producer Guild Awards, Directors Guild Awards, Writers Guild Awards, and ending with the granddaddy of them all, the Academy Awards show.

During my career, I was blessed to perform on 30 Oscars telecasts, spent 28 years on the Golden Globes, performed the SAG Awards from 1995-2014 and the Grammys for over 20 years. When I started doing the Grammys, Jack Elliot had the house band (for over 40 years there was a house band on this show; now they just hire our local musicians as needed for any acts that want strings, etc.). Julius Chaikin was the contractor on many of those shows.

Live vs Pre-Recording

When it comes to Live TV and awards shows, I have always felt that having the band at the venue and on the set, filmed live, adds that much more class to the production. Without the band on set, even if the music was pre-recorded by our musicians, the folks at home would just think they are using records. That is what I call "out of sight, out of mind."

When I finally hung up my horn and became VP, I decided that I would use my voice and office to right some wrongs that have going on in the Live TV world. First off was to get the musicians on the Oscars back into the pit. During my last four years of playing on the show, we were sitting at Capitol Studios playing live to the world, and we got our one obligatory shot of the orchestra. I also wanted to get something that we never received in the 64 years of the Oscars on television — I wanted our musicians to get credit on the crawl at the end of the show. I am thrilled to say that both of these items have been taken care. Number one, the musicians are back in the pit. I contacted the executive producer of the show, Rob Paine, and simply asked if this could happen. He said he would take care of it, and sure enough, now our musicians are back in the pit playing the show live to the world.

I thought it would be harder to get the musicians' names on the end credits. I went into Rob's office about four weeks before the 2017 Oscars show and asked what the chances were. He look at me and said, "Rick, there are names on the crawl that shouldn't be there, but the musicians names should be." With that he picked up the phone and called the Academy and said he was sending over 55 musicians' names, plus arrangers and copyists, to be put on the crawl. With that, for the first time in 64 years, the musicians were named in the end crawl. Rob said he hopes this new tradition will continue going forward, and I believe him. Thank you Rob, you are the man.


Live, Laugh and Love

February is here and it's a time that we celebrate the lives of two truly great American heroes: George Washington and Abraham Lincoln. George Washington was Commander of the Continental



Army that defeated the British in the Battle of Yorktown in 1781 and became the first President of the United States. Abraham Lincoln was the 16th President and guided the nation through its darkest hours of the Civil War. He fought to unlock the chains of slavery. He paid the ultimate price at the hands of an assassin, an early casualty in a century-long struggle for equality, voting rights and social justice. What they had in common was a love of liberty and a resolve to fight and die for the freedoms that we often take for granted.

Among those freedoms are freedom of assembly, a free press, the freedom to criticize the government, the right to organize and the right to vote to determine our own destiny and to choose our leaders. With these rights come responsibilities; the duty to participate in meetings and express our opinions, the duty to work to protect our common interests and especially the duty and absolute right to vote. What a contrast with our current leader, who espouses racism and white supremacy, separates migrant children from their parents, wants to wall off America from the rest of the world and is proud to starve hundreds of thousands of working Americans and their families just to make a political point.

February is also Black History Month. It's a time to celebrate the contributions of African Americans to our national fabric and culture and to track the progress of the struggle for dignity and equality. As a society we've come a long way, but there's still a long road ahead. Sadly, bigotry and prejudice are alive and well in America. One only has to follow the daily news to hear about voter ID laws and other voter registration restrictions, reduced voting hours, gerrymandered congressional districts and more policies the president supports, all designed to make it harder for African Americans and other minorities to vote. In 2019? Really?

Here at Local 47, we have our very own American hero, drummer Earl Palmer. Earl was born and raised in New Orleans, where he began his illustrious career as a tap dancer with his mother on the black vaudeville circuit. After studying piano and percussion at the Grunewald School of Music he became active in the New Orleans scene, famously recording with Fats Domino and Little Richard. He moved to Hollywood and joined Local 47 in 1957. Soon he was a regular session player with the Wrecking Crew, who recorded for practically every famous L.A. rock band in the 1960s. 

his 30-year career here he also recorded with artists including Dizzy Gillespie, Count Basie and B.B. King. He was also a staunch union supporter and was elected as Local 47 treasurer in 1982 and again in 1990. Earl died in 2008 and left behind an amazing legacy of thousands of records, motion pictures and television shows as one of Local 47's most famous members.

Each year Local 47 pays to the AFM \$56 for every regular member. This is referred to as "per capita" payment. According to the AFM Bylaws, you are entitled to a refund of the per capita from Locals you belong to in access of two. So, if you belong to three Locals you will receive \$56, four Locals \$112, and so on. To take advantage of this offer, simply <u>download the form here</u>, and send it to the AFM, along with verification of your memberships. You can call my office at 323.993.3159, and we will be happy to provide you with a letter verifying your membership in Local 47 in 2018.

Dr. Martin Luther King on the Importance of Jazz Music

Minister, activist, civil rights leader, visionary — Dr. Martin Luther King Jr. was many things during his all-too-short life. In addition to being all these things, Dr. King was also a huge admirer of jazz music; so much so, in fact, that he was invited to write the forward for the first annual Berlin Jazz Festival in 1964.

That year was a momentous one for Dr. King; Times Magazine named Dr. King "Man of the Year," he was a finalist for the Nobel Peace Prize, and was instrumental in getting the Civil Rights Act passed and was there when it was signed. In July 1964, the director of inaugural Berlin Jazz Festival asked Dr. King to write a few words about jazz to be included in the program for the event program to be held that September, to which he readily obliged.

Foreword written by MLK for the first Berlin Jazz Festival, 1964:

"God has wrought many things out of oppression. He has endowed his creatures with the capacity to create — and from this capacity has flowed the sweet songs of sorrow and joy that have allowed man to cope with his environment and many different situations.

"Jazz speaks for life. The Blues tell the story of life's difficulties, and if you think for a moment, you will realize that they take the hardest realities of life and put them into music, only to come out with some new hope or sense of triumph.

"This is triumphant music.

"Modern jazz has continued in this tradition, singing the songs of a more complicated urban existence. When life itself offers no order and meaning, the musician creates an order and meaning from the sounds of the earth which flow through his instrument.

"It is no wonder that so much of the search for identity among American Negroes was championed by Jazz musicians. Long before the modern essayists and scholars wrote of racial identity as a problem for a multiracial world, musicians were returning to their roots to affirm that which was stirring within their souls.

"Much of the power of our Freedom Movement in the United States has come from this music. It has strengthened us with its sweet rhythms when courage began to fail. It has calmed us with its rich harmonies when spirits were down.

"And now, Jazz is exported to the world. For in the particular struggle of the Negro in America there is something akin to the universal struggle of modern man. Everybody has the Blues. Everybody longs for meaning. Everybody needs to love and be loved. Everybody needs to clap hands and be happy. Everybody longs for faith.

"In music, especially this broad category called Jazz, there is a stepping stone towards all of these."

in-review for 2018, remarking on workshop trainings, organizing outreach, the new AFM video game agreement, our new mentorship program with the Verdugo Board, film and TV tax credits, our Grand Opening building dedication, new CBAs, and ongoing negotiations. He then turned the discussion for what's to come in 2019, including hosting the AFM Western Conference in Glendale this February, the AFM International Conference in Las Vegas this summer, Phase 2 construction for our multi-purpose facility, and the continuation of our Strategic Plan. He shared that our Legislative and Wage Scale committees need new appointments, and invited members to get involved.

Recording Musicians Association International President Marc Sazer and RMA Board Member Allison Allport gave a presentation on the Motion Picture/TV Film negotiations, which will continue in March.

Vice President Rick Baptist reported that the Music Fund golf tournament fundraiser held in October raised over \$17,000 for musicians in need. Our rehearsal rooms are enjoying lots of activity and receiving lots of new and returning members. He also

reported that Studio 47 should be up and running within the next two months.

Secretary/Treasurer Gary Lasley presented the 3rd quarter review of the Local's finances, and shared that the 2019 Wage Scale books and Directory books will be available within the coming weeks. He also shared that Local 47 once again received a number of accolades from the International Labor Communications Association, earning honors for our various print and digital publications. Following the Inaugural Meeting, the annual meeting of the Musicians' Club took place. Baptist updated members on the status of the building and plans for Phase 2 construction, and Lasley reported on the Club financials.

UTLA Wins

Less than a month into 2019, the teachers of Los Angeles proved that last year's wave of collective action isn't quieting down. After taking to the streets in a strike that has captured the country's imagination, members of United Teachers Los Angeles are returned to classrooms after overwhelmingly approving a paradigm-shifting contract that delivers on key demands.

AFM Local 47 musicians proudly stood alongside our sisters and brothers of UTLA in their fight to improve our schools. Most of the rallies took place during a rare SoCal rainstorm the week of Jan. 14, but tens of thousands weren't deterred from taking to the streets to stand up and do right by our students, our teachers, and our communities. For six days, more than 30,000 UTLA teachers went on strike to shine a light on the daily realities of a neglected and underfunded public school system.

They demanded better, and by standing together, they won it.

Here are just a few critical improvements in UTLA's new contract:

- A much-deserved 6% pay raise with no contingencies
- A nurse in every school five days a week
- A teacher librarian in every secondary school five days a week
- Hard caps on class size that will go into effect immediately in

2019-2020, with additional improvements every year after

- A commitment to reduce testing by 50%
- Hard caps on special education caseloads
- A clear pathway to cap charter schools

"For too long teachers have lived with a hard truth to tell—that for years our students were being starved of the resources they need," said UTLA President Alex Caputo-Pearl following the vote. "Our expectations were fundamentally raised by this strike. Together, we said we deserve better, our students deserve better. We must keep our expectations high and not let go of this moment, because the next struggle is right around the corner."

SAG-AFTRA fights to protect commercials contract

Union commercial work is under attack, and SAG-AFTRA members are fighting back.

A crowd of more than 1,000 actors and supporters including musicians, stage performers, stunt workers, directors, writers, and Teamsters held a rally in Los Angeles on Jan. 23 calling out ad agency Bartle Bogle Hegarty for abandoning its responsibilities as a 20-year SAG-AFTRA signatory by shooting non-union commercials.

Leading the march from SAG-AFTRA headquarters to a rally on the La Brea Tar Pits lawn was an all-union Local 47 drumline. A group of fiery speakers took to the stage including SAG-AFTRA President Gabrielle Carteris, SAG-AFTRA Los Angeles President Jane Austin, actor Patrick Fabian, AFM Local 47 President John Acosta, LA County Fed President Rusty Hicks, Teamsters Local 399 Secretary/Treasurer Steve Dayan, IATSE Second International Vice President Thom Davis, and L.A. Board of Public Works President and chief film liaison to the Mayor, Kevin James.

"I have a message for you today," President Acosta said from the stage. "We are with you. Your fight is our fight. An injustice against an actor is an injustice against a musician... And we have a special telegram for BBH: Shame on you. Shame on you for attacking middle-class jobs. Shame on you for attacking health care. Shame on you for attacking pensions."

Solidifying AFM's commitment to standing with SAG-AF-TRA, Acosta proclaimed: "As long as you are out, we are out. We are with you… Because if there's no contract, there is no peace."

SAG-AFTRA has been on strike against BBH since Sept. 20,

If you are being pressured to participate in non-union work or take financial-core status and quit the union, know that it is illegal for employers or employers' representatives to coerce, pressure or otherwise influence any employee to take fi-core status under the National Labor Relations Act. Should this happen to you, call 323.993.3130.

Your Union will take action — with legal counsel if necessary — on your behalf to ensure your rights as a union worker are protected.

Musicians' Club of Los Angeles: What You Need to Know

As a member of AFM Local 47, you may be surprised to know that you are also automatically a member of the Musicians' Club of Los Angeles. Here's a quick rundown of what the Club is and what it means to be a member.



What is the Musicians' Club?

The Musicians' Club of Los Angeles is a tax-exempt, nonprofit building corporation officially incorporated by the State of California in 1924.

Why was it formed?

The Musicians' Club was formed for the purpose of holding title to the real property from which AFM Local 47 conducts business. The Club uses these rental payments to defray the cost of running the headquarters property. It is a common practice for labor unions in California to hold title to their property through building corporations.

Who are its members and officers?

Any member in good-standing of Local 47 is also a member of the Musicians' Club. Membership in good standing for Local 47 is determined and governed through the Bylaws of Local 47. Per the Bylaws of the Musicians' Club, the officers of the Club are the duly elected officers of Local 47. The duly elected officers of Local 47 hold the same office they were elected to in Local 47 for purposes of governing the Club (e.g., the President of Local 47 is the President of the Musicians' Club, the Executive Board of Local 47 is the Board of Directors of the Club).

When are meetings held?

The annual meeting of the Musicians' Club is held in each even-numbered year, on the fourth Monday in January; and, in each odd-numbered year (following the biennial election) on the second Monday in January, at which meeting the officers retiring from office shall report their final accounts and turnover all property to their duly elected successors. At a regular or special meeting, nine members constitute a quorum for the purpose of acting on all routine business, but on matters relating to amendments of the Constitution or Bylaws, 12 members constitute a quorum. The Board of Directors conducts Club business at regular meetings.



AFM Pension Update

Last month, Congress introduced bipartisan legislation that would ensure multi-employer pension plans remain solvent and continue providing retirees and working people the retirement benefits they have earned.

The Rehabilitation for Multiemployer Pensions Act, also known as the Butch Lewis Act, would ensure that all promised benefits are paid by creating a new office within the U.S. Treasury Department called the Pension Rehabilitation Administration (PRA). The PRA would issue bonds backed by the U.S. Treasury to finance loans to distressed pension plans so they can remain solvent and continue providing retirement security for retirees and workers for decades to come.

<u>Tell your member of Congress to Protect our Pensions now!</u>

Detailed information about the June 2018 update to the AFM-EPF rehabilitation plan can be found <u>here</u>. In a nutshell, it is mandatory that employer pension contributions be increased 10% for collective bargaining agreements that expire on or after August 1, 2018 and for single engagements where LS-1 is filed after November 1, 2018. For example: a 10% pension contribution would become an 11% contribution. Also, "Amounts paid to the Fund as a result of the 10% increase in the contribution rate will be used solely to improve the financial health of the Fund. Those amounts will not be considered when calculating a pension benefit and therefore will not increase future benefit payments to participants."

My Personal Experience at the Celebration for John Williams

I read the glowing review by Mark Swed of the first night of the Celebration of John Williams in the Times last month, and was moved to have a personal kind of celebration; of knowing John Williams, from our time in Tucson in the 775th Air Force band, through my time as Union VP and President, when I presented both John Williams and Steven Spielberg a commemorative plaque on behalf of Musicians Local 47 at a scoring session of 105 players. The plaques were inscribed with our Local 47 musicians' thanks for consistently scoring their films here in Hollywood, and thereby using our musicians in the resulting scoring processes. Mr. Spielberg told me at that time that he was genuinely touched by this recognition.

So I was fortunate get a ticket and attended the sold-out concert

Saturday evening, Jan. 26. The Disney Hall audience was treated to a sparkling, rewarding evening; hearing John's great scores played by our superb Los Angeles Philharmonic Orchestra with Gustavo Dudamel conducting.

After the last notes were played, and maestro Dudamel and the orchestra acknowledged the tremendous applause, he turned to the stage door, and John Williams stepped out on stage to thunderous applause. Gustavo welcomed him and they hugged and exchanged words which we could not hear. Then John went off to a thunder of cheers and clapping. But he reappeared, an usher presented our wonderful conductor with a large bouquet of flowers — and John took charge.

He motioned Dudamel to take a seat; the first audience chair just below the stage. Gustavo did so as a librarian hurried out and placed another score on the conductor's stand. John mounted the podium, picked up the baton, the orchestra responded, and John gave the downbeat to the most extraordinary arrangement of "Happy Birthday" that I have ever been delighted to hear!

The first entrance was the first notes of the song played precisely by the timpanist, who was then joined by the entire percussion section in a complex, fun-filled rendition — while Dudamel, whose birthday it was, beamed, sitting in the audience. This amazing arrangement then featured the woodwind section, playing "Happy Birthday" as John would have arranged it for a Harry Potter film perhaps, with all brilliance of his orchestrative renown on display! Then the French horns had their contrapuntal turn exploring that much loved old refrain. The strings reprised the theme in a virtuosic turn. Finally was the trumpets, trombones and tubas turn to shine! It was a revisiting of the sounds and style of the "Indiana Jones" scores, with a touch of "Star Wars" synchronicity! After a whole evening of John's demanding scores, it was a lot to ask, but the brass section, highlighted by the trum-

pets, played flawlessly.

Then Williams turned to us, the audience, and motioned us to stand up and sing; and of course we did. It was "Happy Birthday" in a huge chorus, with great gusto to Gustavo, who came back up on stage where he and John hugged and embraced.

They acknowledged the orchestra, and the audience, then made their way to the stage door, arm in arm. They came back as the audience signaled with cheers and tremendous applause for the two to return.

And so an unforgettable evening with Gustavo Dudamel, John Williams, and the entire, expanded, Los Angeles Philharmonic Orchestra came to a joyous and unforgettable conclusion.

I write this because during this time of national uncertainty and serious problems worldwide, this evening of great music, with remarkable performances by a great orchestra, united with a loving audience, bring us together like nothing else can.

There *is* hope, and joy and more opportunity to join in the great times that music can bring to all of us.

As MLK said, "We Shall Overcome" — doubt, hatred, selfishness and intolerance, with the great blessing and loving touch of music.



Reconstructive Surgery Fully Covered After Mastectomy WOMEN'S HEALTH AND CANCER RIGHTS ACT OF 1998

The Professional Musicians Local 47 and Employers Health & Welfare Fund ("the Fund") provides you with this notice as required by the Women's Health and Cancer Rights Act of 1988 (WHCRA).

In compliance with WHCRA, the insurers contracted with by the Fund (Kaiser and Blue Shield) provide benefits for mastectomy-related services, including all stages of reconstruction and surgery to achieve symmetry between the breasts, prostheses, and for complications resulting from a mastectomy, including lymph edemas.

Although reconstructive surgery after a mastectomy is generally a covered procedure, some procedures are, of course, classified as cosmetic and, therefore, not covered.

Under the WHCRA, and in the case of a participant or beneficiary who is enrolled with and receiving benefits from the Fund, in connection with a mastectomy and elects reconstruction, federal law requires coverage, in a manner determined in consultation with the attending physician and the patient, for:

- reconstruction of the breast on which the mastectomy is performed
- complications at all stages of a mastectomy, including lymphedemas
- all any necessary prostheses required as a result of the mastectomy
- surgery and reconstruction of the other breast to produce a symmetrical appearance

The above benefits are provided to all enrolled Participants and Beneficiaries subject to the same deductibles and co-insurance payments that are applicable to all other medical and surgical benefits provided by the Fund. NEWBORN AND MOTHERS HEALTH PROTECTION ACT OF 1996 (NMHPA)

Group health plans and health insurance issuers generally may not, under Federal law, restrict benefits for any hospital length of stay in connection with childbirth for the mother or newborn child to less than 48 hours following a vaginal delivery, or less than 96 hours following a cesarean section. However, Federal law generally does not prohibit the mother's or newborn's attending provider, after consulting with the mother, from discharging the mother or her newborn earlier than 48 hours (or 96 hours as applicable). In any case, plans and issuers may not, under Federal law, require that a provider obtain authorization from the plan or the issuer for prescribing a length of stay not in excess of 48 hours (or 96 hours). The Fund, through the insurance benefits provided by Kaiser and Blue Shield, fully complies with the NMHPA.

TO RESIGN IN GOOD STANDING:

In order to resign in good standing, you must email, mail or fax your written request to Local 47 before your membership is suspended. Though dues are due Jan. 1 and July 1, current grace periods extend to March 31 and Sept. 30, respectively; suspensions are posted April 1 and Oct. 1. The reinstatement fee is \$75.
