

President John Acosta



I hope this message finds you well! As we enter into the final month of 2019 I'd like to run down a quick recap of the past year's activities.

We began in January with a new term for an administration that came off an exciting 2018. After our big move to Burbank, we began in earnest to settle into our new home, leveling out our finances and leaning into our Strategic Plan which was adopted by the membership back in 2017. Several programs were launched. In the realm of Education and Community partnerships we began working with the Verdugo Workforce Investment Board on an initiative called the Local 47 Career Pathways program, a new initiative that took Local 47 into surrounding high schools and colleges, introducing students to a career in the music industry and exposing them to what it's like to be professional musician. After a positive start in 2018 with this initiative we expanded our reach into Inglewood, developing another program along the lines of a songwriting boot camp. This new initiative, launched in partnership with the California Federation of Teachers and the Inglewood Unified School District, brought elementary and high school students from Inglewood to the world of professional music making. This program resulted in a series of fine sound recordings that these young musicians can refer back to as they explore careers in the music business.

2019 was a jammed pack year! In addition to successfully negotiating over half a dozen CBAs with increases averaging 9% over three years, we also hosted the AFM Western Conference, conducting panels and workshops on organizing, collective bargaining, and community engagement, and established a Sexual Harassment Prevention committee tasked to develop a new Code of Conduct for all Local 47 members. Also, after many years in the making and working closely with our AFM leadership, we helped craft a new AFM Video Game agreement, which in 2019 alone covered more projects than its predecessor in the preceding four years, generating good union jobs for Local 47 musicians. This year was also an AFM Convention year, and Local 47 Delegates participated at every level of the proceedings, ensuring that your voice was heard and your interest were considered as our federation established policy for the next three years.

It should not be lost on us that in 2019 we embarked on an unprecedented campaign to win a fair and equitable contract in the motion picture and TV industry, with a special emphasis on improving our agreements for made-for-new-media projects. Through the #BandTogether campaign, Local 47 members have been engaged in new and exciting ways, developing leaders throughout our ranks and fortifying our union.

This past year we established the Phase 2 Building Committee comprised of the titled officers, members of the Executive Board and rank-and-file, also assisted by a fundraising consultant to conduct a feasibility study in an effort to determine our ability to raise capital to complete our Multi-Purpose Room. And in 2019 we continued our effort to build consensus around the creation of a Music Trailer Library agreement that would help cover work in this industry under an AFM agreement, knowing full well that over the years millions of dollars of employment to musicians has being done off contract.

Altogether 2019 was a busy a successful year, strengthening our union, expanding our brand and building partnerships outside of our normal sphere of influence. I want to thank my fellow officers, the Local 47 Executive Board, staff, and especially our membership for their continued commitment to our union. Together we are stronger! And I wish you all a very Happy and Healthy Holiday season. Let's make a toast for a most excellent 2020!

Congresswoman Judy Chu, a democrat from the 27th District which includes Pasadena and the Western San Gabriel Valley, has always been a friend of the American Federation of Musicians. She supported the Music Modernization Act and is a strong proponent of the Butch Lewis Act, which authorizes the U.S. Treasury Department to issue long-term, low-interest loans to failing multi-employer defined benefit pension plans. During the mark up of the bill in the Ways and Means Committee, and again on the floor of the House of Representatives, Rep. Chu argued strongly in favor of the bill and mentioned the AFM by name. She also strongly supported the AFM in our negotiations with the Alliance of Motion Picture and Television Producers (AMPTP). I happen to be a constituent of hers, so I was pleased when I heard that the AFM Tempo fund donated \$2,800 to her re-election campaign. I'd like to thank AFM Legislative-Political Director Alfonso Pollard for acknowledging Rep. Chu's support for musicians and allowing Local 47 to have a strong presence at a dinner with her supporters in San Gabriel. At our table were President Acosta, me and Robin, RMA President Marc Sazer, AFM-EPF Trustee Gail Kruvand, Communications Director Linda Rapka, Organizing Coordinator Jefferson Kemper, and Contract Action Team members Mei Chang and Allison Allport.



Recently Local 47 partnered with MusiCares to host an all-day hearing clinic in rehearsal room 4. MusiCares is a non-profit established by the National Academy of Recording Arts and Sciences that has provided over \$60 million in health and financial recourses to musicians and educational institutions. At the clinic over 40 Local 47 members received a free ear exam by an audiologist and custom fitted ear plugs. I'd like to thank MusiCares for their generous and continuing support for Local 47 musicians.

As 2019 comes to an end, I'd like to thank each and every one of you for helping to make it a good one for Local 47 and for listening to my monthly story. And finally, however you celebrate, I'd like wish the happiest of holidays to you and your family.

Musicians Reach Tentative Deal With Film and TV Studios

Despite major improvements won, the fight for streaming residuals will continue

After more than two years of tough negotiations, musicians have reached a tentative agreement with major film and television studios that includes many substantive improvements and no significant concessions — yet still does not include residuals for work on made-for-streaming films and episodic TV shows.

Members of the American Federation of Musicians have been negotiating a new contract with major studios including Disney, CBS, MGM, Paramount, NBCUniversal Sony and Warner Brothers, and the newly proposed contract features several major improvements for musicians. For the first time in history, musicians will receive screen credits when they perform on theatrical and streamed film scores. Also for the first time, the proposed deal establishes fair wages and conditions for high-budget shows made for streaming platforms.

Economic improvements include an increase in musician residual payments for shows rented and purchased online, as well as 3% per year wage increases. Musicians successfully resisted attempts by the studios to impose unjustified concessions, including those that would allow studios to score more TV shows and films abroad.

While these unprecedented achievements are significant wins for musicians, their biggest demand — residuals for work in new media — was not included in the final offer by the Alliance of Motion Picture and Television Producers. While the studios continue to refuse industry-standard residuals for new media projects, musicians have made it clear that this is still a priority and that we will continue to fight for this basic standard.

“The campaign for fairness in our contract with the studios, particularly on the issue of compensation and residuals for content made for streaming, has energized not only our film and television musicians in Los Angeles, New York and Nashville, but musicians throughout the country,” said Ray Hair, president of the American Federation of Musicians of the United States and Canada. “The tentative agreement, if ratified, will be viewed as a short-term truce. While we’ve made meaningful progress on how we are recognized and treated when we perform scoring sessions for theatrical and long form new media productions, our musicians’ concerted activity will continue as the backdrop to our ongoing efforts to obtain fair residual terms whenever we are engaged to score content made for streaming.”

Earlier this year, musicians across the country launched the grassroots #BandTogether campaign, holding rallies, staging informational leaflets, and leading other public actions to raise awareness about the significant impact new media residuals will have on their ability to earn a living in the industry.

The proposed agreement is subject to a ratification vote by members of the bargaining unit, and if approved will cover a period of two years expiring Nov. 14, 2021. But until residuals for new media are achieved, musicians have no plans on backing down.

A Peek into the World of a Los Angeles Studio Musician

I am not sure what it's like in other recording centers, but in Los Angeles there are a few hundred highly skilled musicians who are equipped to play any piece of music on any instrument you can imagine, and in any style that exists. Some have been on the scene for decades and some have arrived relatively recently. All of them are consummate professionals who are committed to maintaining and preserving a tradition of being able to "do it all." Some have achieved a high level of notoriety and their names are known. Most of the best ones, however, are people you've never heard of — and they'd like to keep it that way. If you saw them on the street, you would never dream that they were capable of producing the kind of music that comes from their fingers, or out of their bells, mouths, or amplifiers. Many of them are people who I am proud to call colleagues and good friends. What follows is an attempt to bring the studio experience to life for those who don't quite know what happens when the red "Recording" light comes on.

When you walk into a large recording studio for the first time your senses quickly become overwhelmed by all of the stimulation. Over there is the famous composer casually talking to the contractor whose name you only know from movie credits. Sitting in the chair next to yours is a musical icon whose playing you first heard on Michael Jackson's albums and who now plays on virtually every movie soundtrack. Over there is the guy who played the bass line on the "Barney Miller" TV show theme. As if all this wasn't enough to intimidate you, there are pictures on the walls in the hallway of Frank Sinatra, Judy Garland, and Barbara Streisand when they recorded their music in this very space. It's pretty intense... but also very cool.

YOLA Joins LA Phil in Mexico City

In November, 96 musicians from Youth Orchestra Los Angeles joined the LA Phil on a five-day tour of Mexico City. The first ever cross-site full orchestra to go on an international tour with the LA Phil, the YOLA orchestra participated in a cultural exchange, titled “*Encuentros*,” with approximately 100 students from Mexico City ages 15-20 for a series of intensive music and leadership-focused workshops, rehearsals, and masterclasses led by LA Phil Associate Conductor Paolo Bortolameolli and LA Phil musicians.

The program culminated in a free, open rehearsal with Gustavo Dudamel on Nov. 13 at the *Palacio de Bellas Artes*, and a free daytime performance for school children by YOLA on Nov. 14 at the *Teatro Julio Castillo*. Participants also explored topics including cultural unity, interculturality, and building bridges through music, as well as celebrate 50 years of sisterhood between Los Angeles and Mexico City. “*Encuentros*” is a collaboration between YOLA, Sistema Nacional de Fomento Musical en México, Music Schools of INBAL, and the Gustavo Dudamel Foundation.

The LA Phil and the Music Center kicked off YOLA’s tour to Mexico City with *Día de la Familia*, a family-friendly event with performances, art making, bilingual storytelling, and kid-friendly activities featuring YOLA, conducted by Bortolameolli, and *Mariachi Los Camperos*.

In its 13 years of existence, YOLA has demonstrated significant impact not only in Los Angeles, but also, more recently, around the world. More than simply an opportunity to travel and perform abroad, each YOLA tour has been shaped artistically, educationally, and culturally by the cities visited and the partner organizations involved.

Each year, the LA Phil chooses a select group of YOLA musicians to join the orchestra on tour and form relationships with their peers from local youth orchestras, as well as LA Phil musicians, international musicians, and top-tier educators. They hold side-by-side rehearsals, student-designed mini-conferences and seminars, and teaching-and-learning residencies at conservatories and concert halls. Past locations have included Boston, Tokyo/Fukushima, broader California, Seoul, Edinburgh, and London.

The LA Phil tour is generously supported by Plascencia Universal and Michele and Dudley Rauch Touring Fund. More information about the LA Phil’s tour can be found at laphil.com/tour.

Meet New LA Fed

President Ron Herrera

Longtime Teamster leader helms workers' coalition of 300+ local unions representing 800,000 members

Ron Herrera was sworn in on Oct. 22, 2019 as President of the Los Angeles County Federation of Labor, AFL-CIO. Herrera, Secretary-Treasurer of Teamsters Local 396, was nominated unopposed by the LA Fed's House of Delegates at their September meeting.

"The L.A. Fed has a 135-year history of winning a just Los Angeles for the people who give this city everything it has, and today its programming is setting the gold standard for responding to an anti-labor federal government and a corporate world with too much power over ordinary Americans' lives," said Herrera. "From the organizing work our labor movement did to respond to the Janus decision, to the innovative programming of the Miguel Contreras Foundation, to the continuing electoral work of finding and lifting up leaders from within our ranks, our movement is building power and securing rights for all workers."

"For close to 30 years, Ron Herrera has been a champion for working families," said John Grant, President of United Food and Commercial Workers Union Local 770. "Because of his work over decades, immigrant waste haulers can support their families with family-wage paychecks, and Southern California is a cleaner, healthier and more just place to live."

Ron Herrera grew up in a union family, hailing from the working-class Los Angeles neighborhood of Wilmington. His father was a member of the International Longshore and Warehouse Union. His grandfather was a veteran of the copper mines of Arizona, fighting the kinds of abuses and discrimination portrayed in the classic strike film "Salt of the Earth."

Herrera became active in the Teamsters Union as a driver at UPS. He first emerged as a union leader in the largest strike in U.S. history, the 1997 Teamsters strike of UPS that reversed a trend towards low-wage part-time employment.

In 2003, Ron was elected as the Secretary-Treasurer of Teamsters Local 396. He soon became a national leader as the first Latino national vice president of the International Brotherhood of Teamsters.

Among his notable efforts at the Teamsters were the decades-long effort to raise standards of living for sanitation workers. Like many other Southern California industries, it saw wages dive as employers forced out longtime employees in favor of new immigrants with little bargaining power. Steady organizing and contract campaigns reversed that trend, lifting standards in the industry through higher wages and benefits, and securing groundbreaking contract language protecting immigrant workers from unjust termination.

Herrera was also a key leader in the Don't Waste L.A. campaign, which united environmental, community, and labor leaders to create an innovative franchise system that increased recycling efforts across the Los Angeles city and raised industry standards.

"The LA Fed is the key vehicle for working people to build power through political action, organizing, and innovative programming," said Roxana Tynan, Executive Director of the Los Angeles Alliance for a New Economy. "At LAANE we have had the good fortune to work with Ron on the Don't Waste LA campaign, and have seen his ability to build coalitions and his commitment to fight for what is right. We are excited to continue the struggle together."

"There's a fire in the hearts of L.A.'s workers that can transform our city if we listen to them and we let them lead," Herrera said. "I'm honored and humbled to serve the people who give this city everything it has. Together, let's build an inclusive, innovative labor movement for all workers."

The previous president, Rusty Hicks, was elected as chair of the California Democratic Party earlier this summer.

Gloria Carol Ramsey

Life Member. Recorder

1/6/1926 - 4/26/2019

Born in Daytona Beach, Florida and passed away peacefully in Ojai, California. She studied at the University of Southern California, receiving her BA in 1948 and her Master in Musicology in 1958. She received a Fulbright grant to the Paris Conservatory; a Queen Elisabeth of Belgium research scholarship; studied musicology at the Sorbonne; and received the *License de Concert* in Clarinet.

Gloria was a pupil of Nadia Boulanger and studied Medieval and Renaissance music with Professor Safford Cape. Gloria played a wide range of early music instruments including recorders, harpsichord, crumhorns, lute and percussion. She was a renowned conductor of early music ensembles. She performed concerts in France, Italy, Holland, Portugal, and throughout the United States. She led hundreds of workshops around the world, including the University of Vancouver and the National Music Camp in Interlochen, Michigan. She was the founder-director of the Siena International Recorder Course in Siena, Italy and toured Europe as a member of the Ramsey/Raynaud Baroque Duo. Gloria was president and past music director of the Southern California Recorder Society. She generously shared her passion for music with young and old alike. She will be greatly missed.

She is survived by her partner of 54 years, Diana Kellerman. In lieu of flowers, we ask donations to be sent in her memory to the Music Academy of the West, Santa Barbara, California. A memorial service to honor her memory will be announced. PLAY ON!

Should I Have a 'Living Trust'?

"Living" or revocable trusts are not just for the wealthy. A trust can provide for the management of your assets if you become ill and unable to handle your affairs, or if you pass away. The person(s) you choose can assume responsibility for your financial affairs in an accountable fashion, and without court supervision.

Another advantage of a living trust over a mere will, particularly where there is an estate in excess of one hundred thousand dollars, is, quite simply, that wills are subject to Probate and trusts are not. If a Probate is required, statutory fees for attorneys and executors in California are among the highest in the country. For example, if your gross estate is \$500,000, which would certainly include the owner of a moderate home in many parts of Los Angeles, the state authorizes the payment of fees and commissions totaling \$26,000, plus the Court costs and related expenses. A substantial portion of these costs can be avoided through the proper establishment and operation of a living trust.

The rising costs of probate administration are not unwarranted. It can be a time consuming and unwieldy process. Even a simple Probate proceeding will take a minimum of nine months in Los Angeles County.

In our practice, we often see people who have estates larger than anticipated. High real estate values, even in the current market, often translate into a significant increase in estate assets. This real property, if not held in a trust, may be subject to probate, which could mean a drawn out and expensive Court procedure.

Your undertaking the preparation of an appropriate estate plan, often involving the preparation of a living trust, is of even greater financial benefit today than ever before.

2020 Health and Life Insurance Eligibility

Eligibility & Enrollment Information

Please watch your mailbox as the Fund will be mailing Eligibility and Enrollment information to eligible participants in approximately mid-November of this year. The Fund will mail enrollment materials to the participant's last address on file with the Fund's Administrative Office, so please ensure that the Fund has your most up-to-date address information.

The enrollment materials will advise the eligible participant at which Level of coverage they have qualified (A, B or C), based on employer contributions the Fund received on the participant's behalf during the most recent Qualifying Year: October 3, 2018, and October 2, 2019. Benefit summaries, co-premium costs and out-of-pocket expenses for the applicable Level are available on the Fund's website:

pacfed-musicians.com.

The qualifying Levels and available benefits are as follows:

Again, and in order to be covered by one of the Fund's benefit plans, for the Coverage Year beginning January 1, 2020, you must (A) have accumulated a minimum of \$700 in employer contributions, for work performed October 3, 2018 through October 2, 2019, and (B) complete and return, to the Fund's Administrative Office, the applicable enrollment form, along with the proper co-premium remittance no later than December 20, 2019.

Vision / Dental Plan Enrollment Changes for 2020

Starting with the Coverage Year effective January 1, 2020, a Participant that qualifies – based on Employer contributions remitted during the prior Qualifying Year (here; October 2, 2018 – October 3, 2019) – for all Levels “A” “B” or “C” coverage may be waived the Medical portion of the coverage and enroll in Dental and Vision only. In order to be entitled to benefits/coverage from the Fund's Dental Plan and the Vision Plan, the Participant must also properly and fully complete the required Enrollment Form, remit any required co-premium and timely send both to the Fund's Administrative Office. Failure to timely and fully complete the Enrollment Form, and remit any co-premiums then due, will impact the Participant's ability to obtain Dental Plan and Vision Plan benefits and coverage.

A new form to select/enroll in “Dental/Vision Only” has been created and must be completed, signed and returned to the Fund Administrative office within the Open Enrollment period (November 20 through December 20, 2019).

Life Insurance Coverage Requires Eligible Participants to Complete a Beneficiary Form

A Life Insurance Plan benefit of \$20,000 is offered by the Fund to all eligible participants. **Enrollment in one of the Fund's medical plans is not required; however, to be enrolled in and covered by the Life Insurance Plan (which includes an AD& D benefit), a completed, signed beneficiary form must be submitted to the Fund Administrative office during the Open Enrollment period (November 20 to December 20).** Information regarding the Fund's Life Insurance Plan and benefits are included in the annual enrollment materials/package. You can also find information about the Life Insurance Plan on the Fund's website: pacfed-musicians.com.

If you do not complete an insurance beneficiary form neither you nor your beneficiaries will be enrolled in the Life and AD&D benefit provided by the Fund through Prudential. In the event you are not enrolled in the Life Insurance Plan, your beneficiaries will not be eligible for any benefit payment whatsoever.

Also, please be sure to update your Life Insurance Plan beneficiary card so that the Fund has up-to-date information on who you want to receive the benefits in case of a claim.

Dues Schedule

- Annual and Semi-Annual Membership Dues for Regular, Life and Inactive Life Members are due **Jan. 1** of each year. Payment must be received by **March 31** (three-month grace period) to avoid suspension. If not paid by this date, a \$75 reinstatement fee will be assessed. **Both dues and reinstatement fee must be paid by June 30 to avoid expulsion.**
- Likewise, Semi-Annual Membership Dues for Regular Members are due **July 1** and must be received by **Sept. 30** (three-month grace period) to avoid suspension. If not paid by this date, a \$75 reinstatement fee will be assessed. **Both dues and reinstatement fee must be paid by Dec. 31 to avoid expulsion.**

Work Dues Notices

At its Dec. 9, 2014 meeting, the Local 47 Executive Board passed the following motion:

“As a matter of policy, Local 47 will no longer mail checks to members or non-members whose delinquent work dues liability is in excess of \$1,000. When the Local receives a payroll check for anyone who has such a delinquency, the member or non-member shall be contacted by the Secretary/Treasurer’s office. Notice From the Executive Board: Work Dues Delinquency and Suspension

- 1) Local 47 members whose work dues delinquency exceeds \$500 shall be suspended; and
- 2) Non-Local 47 members whose work dues delinquency exceeds \$500 shall be referred to the IEB as provided in the AFM Bylaws.

In order to reinstate membership, a \$75 reinstatement fee will be assessed.

Resignation Policy

In order to resign in good standing, you must email, mail or fax your written request to Local 47 before your membership is suspended. Though dues are due Jan. 1 and July 1, current grace periods extend to March 31 and Sept. 30, respectively; suspensions are posted April 1 and Oct. 1. The reinstatement fee is \$75.

In addition to membership dues, all other financial obligations, Local and International, must be paid prior to resignation. Your letter of resignation will be presented at the following Executive Board meeting and a written response will be mailed to you. Don’t wait! If you wait, you will be required to pay another half year’s dues and/or clearance fee.

Multiple-Card AFM Member Rebate

Did you know? If you hold membership in three or more Locals throughout a full calendar year, you are entitled to a rebate from the AFM.

Under the rebate program, membership in a base of two Locals must be established in order for a member to qualify for a rebate.
