



The month of May begins with a significant date in the Labor movement.

May 1 is known as International Workers' Day – a day celebrated around the world. In the United States, May 1, 1886, was the day workers began a nationwide strike, calling for an eight-hour workday. In Chicago, this strike, which became known as the Haymarket Affair of 1886, was marked by violence, resulting in both injuries and deaths.

But what does this have to do with our profession in 2023? Unfortunately, quite a bit.

In recent weeks, I have encountered employers who have subjected musicians to unsafe working conditions, enacted punitive, retaliatory actions when billed for overtime, recorded musicians in concert without compensation, and made attempts to negotiate substandard wages. These actions are simply unacceptable, and these employers are being dealt with swiftly and firmly.

The public doesn't always perceive professional musicians as labor – frankly, we don't always see ourselves that way. But the reality is that, to employers, we are a workforce, with all that that label entails.

However, we are also highly skilled, highly trained, artists and we create a product so magical and so essential, that most people cannot imagine living without it. These truths, I feel, are the source of our strength and our power. Our employers are unable to do our jobs and cannot be taught how to do them they are wholly dependent on musicians to make music.

What's new at the Local?

A highly successful jazz festival, several new collective bargaining agreements, the launch of a contract action campaign for the upcoming film and television negotiations, an election for a permanent secretary/treasurer, and the first steps towards the creation of a coalition of entertainment unions.

And perhaps most notably, we have hired an organizer. Organizing is not only the basis for what we do as a labor union, it is also essential to our growth and our continued ability to protect our

members and our profession.

I invite you all to come by, visit, stay for coffee, and talk about our future.

Officer Reports

Vice President Marc Sazer

May is upon us, and promises to be an exciting month for Local 47. Our rehearsal rooms are buzzing with activity; after a great



deal of consideration, our Executive Board voted in April to lift our Covid mandates. This allowed us to invite everyone into our building for the Jazz Festival, and for our General Membership meeting held on April 24. It is a relief for us to see each other face to face, to share space, music and unionism together in person!

Our Electronic Media Division, which my office

oversees, is responsible for getting reports and checks from employers and payroll companies, vetting and processing them, and getting them out the door to musicians. We have had ongoing problems with late payments from companies and payroll companies, and we have been active in trying to counteract this problem. Since we can only address late payments if we have advance notice of AFM sessions, we have asked all musicians to "crowdsource" this information through this secure, anonymous online form: <u>afm47.org/sessions</u>. Musicians are getting paid on time more often now! It works — keep the participation coming!

Unfortunately we have had a couple of instances of mail theft from the U.S. Post Office. We've learned that this is a national problem, but we have taken what steps we could. I visited our Burbank Post Office, spoke with a floor manager, and was assured that they are taking new security measures, and gave us a new procedure for dropping off mail in an area that will be under direct human supervision at all times. I have to remind myself that we mail around 60,000 checks a year (this doesn't include all of our membership and other postal mail). Only a tiny fraction of those have been impacted, but we know how tough it is when a check doesn't show up.

Monday, May 1 will be a big day here at the Local. AFM President Ray Hair, the leadership of a number of AFM Locals that have film and television work in the area, and the Fair Share for Musicians Steering Committee will be meeting for the whole day in our Executive Boardroom. The goal is to plan and strategize for the launch of the Fair Share for Musicians campaign to win a fair contract from the film studios and TV networks in the era of Disney+, HBOMax, and the rest of the streaming world.

It is with real pride that we can report that Local 47 has hired a full-time union organizer to help us with these crucial contract campaigns. Rahul Neuman is a lecturer in Classical Indian Music and ethnomusicology at UCLA, and veteran of their tremendously successful union campaigns at the UC system. He will be a tremendous asset for musicians in seeking fair contracts, and more.

Facing these huge companies will be a challenge. I spent a day as a guest observer at the Writers Guild negotiations. By the time you read this column they may or may not be on strike. The American Federation of Musicians, SAG-AFTRA, I.A.T.S.E., Teamsters 399 and others have offered full support to the Writers Guild; our issues are fundamentally the same for all of us. We all need to be paid fairly when we work on streaming media.

If the WGA is on strike, the more of us that support them the stronger they will be, and the stronger we will be. Local 47 has an online form for you to sign up to be contacted as a supporter. Please join your colleagues in this effort: <u>afm47.org/wga</u>




May Day, also known as International Workers' Day, is a celebration of laborers and the working classes promoted by the international labor movement and occurs every year on May 1.

Traditionally, May 1 is the date of the European spring festival of May Day. In 1889, the Marxist International Socialist Congress met in Paris and established the Second International as a successor to the earlier International Workingmen's Association. They adopted a resolution for a "great international demonstration" in support of working-class demands for the eight-hour day.

The May 1st date was chosen by the American Federation of Labor to commemorate a general strike

in the United States, which had begun on May 1, 1886 and culminated in the Haymarket affair four days later. The demonstration subsequently became a yearly event. The 1904 Sixth Conference of the Second International called on "all Social Democratic Party organizations and trade unions of all countries to demonstrate energetically on the First of May for the legal establishment of the eight-hour day, for the class demands of the proletariat, and for universal peace."





Reggie Watts


KEYBOARD MEMBER SINCE 2015

Reggie Watts

Reggie Watts, known for his improvised musical sets created using only his voice, a keyboard, and a looping machine, refers to himself as a "disinformationist" who aims to disorient his audience in a comedic fashion.

He utilizes improvisation in his solo shows, which consist of him singing and rapping both with words and with sound poetry, accompanying himself by either beatboxing, performing vocal basslines into a loop machine, or simply by playing the keyboard. His act also showcases his trademark style of standup comedy, consisting of him rapidly alternating between topics of discussion in both rational and nonsensical manners, making random sounds and gibberish noises, and speaking in other accents and languages at unexpected times, all with the intent of playfully and comically disorienting his audiences.

Reggie was the regular house musician on the spoof IFC talkshow "Comedy Bang! Bang!" and for eight years led the house band for "The Late Late Show with James Corden," which aired its final episode on April 28.

Gail Kruvand Elected New Secretary/Treasurer

At our April 24, 2023 Local 47 General Membership Meeting, Special Elections took place to fill five vacant offices. The first vote for Secretary/Treasurer yielded the following returns:

<u>SECRETARY/TREASURER – 1 elected</u> Gail Kruvand – 52 Gary Lasley – 4

Kruvand assumed office immediately upon the completion of the ballot count announcement and certification by the Election Board during the meeting. Kruvand succeeds Danita Ng-Poss, who had served as Secretary/Treasurer since January 2021 until her resignation in January 2023.

Gail Kruvand's career as a bassist in New York City spanned 40 years. She worked in many areas including the major orchestras of Lincoln Center, freelance concerts, recording and Broadway. As a member of the New York City Opera Orchestra (and eventually personnel manager) she was on the orchestra committee and elected as a delegate to ICSOM, one of the five Player Conferences in the AFM. Her interest in how people organize themselves to "get things" done" from school PTAs concerned with their childrens' education to orchestra committees seeking better contracts to freelancers who must stand together or fall apart naturally led to union involvement. In addition to her service on the Executive Board at Local 802 from 2010-2017, she graduated from the Cornell University Union Leadership Institute in 2014. Additional studies resulted in a Certificate in Labor Relations from the City University of NY in 2015. Gail was appointed as a rank-and-file trustee to the American Federation of Musicians and Employers' Pension Fund in 2017. As a delegate to the AFM Convention in 2013 and 2016, she chaired the Measures and Benefits Committee in 2016. Gail Kruvand looks forward to having the opportunity to serve as Secretary/Treasurer at AFM Local 47.

Sept. 15 - Omissions distribution.


All issued checks are valid for 90 days only — please make sure to cash them within this time frame before they are stale-dated.

COVID Policy Update



Streaming and Your Livelihood

- It takes an annual salary of \$207,500 to qualify for a mortgage on a median home in Los Angeles.
- If you work primarily on traditional film and TV projects, you would need to play about 145 single sessions per year to afford a median home.

If you work primarily on Made-for-Streaming projects, you would need to play 724 streaming sessions per year. That's 2 sessions a day, 7 days a week, 52 weeks out of the year!

As Made-for-Streaming work (which doesn't produce residuals) continues to eclipse traditional film/ TV work, AFM musicians are finding it increasingly harder to make a living.

It's time musicians unite and demand our Fair Share!

A Message from the Music Performance Trust Fund

As we head into the 2023-2024 scholarship year, we are excited to announce we are continuing our annual scholarship initiatives.

We will continue our Music Family Scholarship which supports the children of professional musicians who are in current good standing membership with a local union. We will have 75 \$1,000 scholarships for these students.

We will also continue our Music's Future Scholarship which supports students pursuing degrees in music. We will have 30 \$2,500 scholarships for these students.

HEALTH CARE BENEFITS

PROFESSIONAL MUSICIANS LOCAL 47 AND EMPLOYERS HEALTH & WELFARE FUND

The Professional Musicians Local 47 and Employers Health & Welfare Fund is administered by PacFed Benefit Administrators. AFM Local 47 negotiates benefits on behalf of our members. The Health & Welfare Trust provides medical, dental, vision, chiropractic, acupuncture, prescription drugs and life insurance to musicians who qualify for benefits based upon contributions received on their behalf in accordance with Local 47 and AFM contracts and collective bargaining agreements.

Eligibility

Eligibility for enrollment in the Health & Welfare Fund is based upon contributions the Fund receives on musicians' behalf from Participating Employers. A Participating Employer, or an Employers' Payroll Designee, has entered into a Collective Bargaining Agreement (CBA) with the Union which calls for contributions to come to the Health & Welfare Fund. All contributions must come from a Participating Employer; musicians may not "self-pay" into the Heath & Welfare Fund.

Coverage

A musician may qualify at one of three levels: Level A (\$1,500+ contribution), Level B (\$1,200-\$1,499 contribution), and Level C (\$700-\$1,199 contribution). Currently the Health & Welfare Fund has contracted with the following benefit providers: Blue Shield, Kaiser Permanente, Landmark Healthplan, Delta Dental, MES Vision underwritten by Gerber Life, and the Prudential Insurance Company of America ("Prudential Life"). To review the Summary Plan Description (SPD), please click here. Any questions regarding a participant or dependent's eligibility and coverage should be directed to the Health & Welfare Fund.

ENTERTAINMENT INDUSTRY FLEX PLAN

The Entertainment industry Flex Plan is an employee benefit plan which combines both Employer Contributions and Employee Contributions to fund benefits including medical, dental, vision, disability, group term life insurance, and dependent care assistance for union members working in Motion Picture and Television. The Flex Plan was established in 1985 to provide Health and related benefits for "Daily-Hire" Union employees working under Collective Bargaining Agreements in the Entertainment Industry.

Eligibility

The Flex Plan covers each person who is employed by an Employer who has entered into a Collective Bargaining Agreement (CBA) with a Local Union providing for Employer Contributions to the Flex Plan. If you are unsure if a specific employer participates in the Flex Plan, contact the Flex Plan. For a complete summary of benefits and information on Employer contributions and Employee contributions, view the Flex Plan Summary Plan Description (SPD).

Coverage

The Plan offers a flexible "cafeteria style" benefit option list in which you design your individual plan according to your needs. If you elect coverage from the Flex Plan Providers, the Flex Plan will make monthly premium payments on your behalf to the carrier(s) you select (provided your account balance) is sufficient to pay all of the premiums). Please refer to the Flex Plan Summary of Benefits for descriptions and monthly costs of the coverages offered. If you do not have sufficient funds in your account to pay your premiums, the Flex Plan allows you to "self-pay" the necessary premiums for a period of 12 months.





AFM Musicians Stand in Solidarity with WGA in Their Fight to Win a Fair Contract

The American Federation of Musicians of the United States and Canada has joined SAG-AFTRA, DGA, and IATSE in support of the Writers Guild of America and its ongoing negotiations for a new film and TV contract.

"We support the writers represented by the Writers Guild of America West and the Writers Guild of America East in their collective fight to win a fair contract," states AFM President Ray Hair. "Writers are the backbone of the entertainment industry. They deserve to be paid fairly for their work in films, network television series, cable and new media productions. Streaming services are now the dominant force in the entertainment industry, and we stand with the writers asking to be compensated fairly for their work."

The Writers Guild of America is currently in contract negotiations with the Alliance of Motion Picture and Television Producers, but the current contract ends on May 1, and the WGA members have officially authorized a strike. The April 17 vote showed that 97.9% of participating union members approved of the potential strike. These results set a new record for both turnout and the percentage of support in a strike authorization vote.



Allen Edward Imbach

Life Member. Trombone 3/11/1938 – 2/28/2023

Allen Edward ("Al") Imbach, legendary Las Vegas and Los Angeles trombone player, arranger, composer, conductor and beloved brother, husband, father, grandfather and uncle, passed peacefully from natural causes on February 28, 2023 in Las Vegas, Nevada with his devoted son by his side. Al was 84 years old.

Born on March 11, 1938 in Van Nuys, California, Al was the younger of Esther and Robert Imbach's two children. He was raised in Van Nuys and took up the trombone at the age of 8.

After graduating from Van Nuys High School in 1956, Al

attended Los Angeles Valley College where he studied music theory and composition and joined the American Federation of Musicians Local 47, Los Angeles. He dropped out of Valley College to pursue a full-time a career as a professional musician.

By 1958 at the of 20, Al was a busy and in-demand professional trombone player in Los Angeles due to his versatile big band, Dixieland, jazz and orchestral playing skills. That year he joined the "Lawrence Welk Plymouth Junior Orchestra," began a six-year, six-nights-aweek stint with Rosy McHargue & His Dixieland Band at The Cottagein Pasadena, California and married Donna Eleanor Lamb.

A year later in 1959, Al's only child, Scott Allen Imbach, was born.

From 1958-1964, Al also appeared with Rosy McHargue's band at such diverse venues as the Porpoise Room at Marineland of the Pacific and Harvey's Wagon Wheel Saloon and Gambling Hall in Lake Tahoe. During this time, Al and his family resided in Southern California in Pasadena, Redondo Beach and Venice.

In 1966 while appearing with Bob Braymond at the Tropicana Hotel in Las Vegas, Al left Braymond to permanently relocate to Vegas, settle down and freelance on the Strip. Shortly thereafter, Al joined the "Casino de Paris" show band at the Dunes Hotel and Casino and began a 23-year run as one of the premier lead trombone players in Las Vegas.

From 1966-1989, Al played in Vegas' premier hotels including the Aladdin, Caesars Palace, the Desert Inn, the Frontier, the Sands, the Riviera and the Stardust. He also played with the Johnny Haig Relief Orchestra. Al performed with legendary entertainers and comedians such as Paul Anka, Tony Bennett, Milton Berle, George Burns, Bobby Darin, Sammy Davis Jr., Tom Jones, Jerry Lewis, Dean Martin, Liza Minnelli, Wayne Newton, Debbie Reynolds, Don Rickles, Frank Sinatra and countless other stars.

Over the course of his 50-year career playing trombone, Al was the lead trombone player with the big bands of Larry Elgart, Claude Gordon, Jerry Gray, Buddy Greco, Carl Lodico, Nelson Riddle and Si Zentner. He also recorded with a variety of legendary artists including Doris Day, Sammy Davis, Jr., Bruce Harper, Johnny Mathis and Tom Jones, among others. Al appeared on numerous soundtracks at 20th Century Fox and Desilu Productions as well as several television shows and specials including "The Jack Benny Show," "The Lawrence Welk Show," "Disney After Dark," "The Golden Globe Awards," "The Jerry Lewis MDA Labor Day Telethon" and "Opening Night USA with Ed McMahon."


Beginning in 2010, Al began a 13-year collaboration with Bruce Harper that continued until Al's passing in 2023. Al contributed arrangements and original compositions to Bruce's highly acclaimed Big Band.

After an amicable divorce from Donna Imbach in 1975, Al married Las Vegas singer/songwriter Lee Ballard in 1981. The devoted couple also enjoyed a successful musical collaboration with Al arranging, composing and conducting for Lee until her passing in 2004.

Al found love for a third time late in life when he met Bobbi Russo. Bobbi was a former dancer, entertainer and showgirl who performed for many years in Las Vegas in a variety of musical productions on the Strip. Bobbi shared Al's love of music and they were inseparable companions for several years until she passed in 2019.

Al was a gentle soul who pursued musical creativity and spiritual growth with a passion. He was compassionate, loving, positive and understanding. Always a great listener, Al shared his wisdom with others when asked to do so and served as a mentor to many people. He was also a great storyteller with a wicked sense of humor. Al's kindness, wisdom and wit will be missed. The world is a better place because Al passed through it.

Al is survived by his son, Scott Imbach, and his sister, Roberta Stimpson. He leaves behind his beloved daughter-in-law, Diane Imbach, his cherished grandchildren, Emily and Tyler Imbach and his dear niece and nephews Kim Elliot and David and Darrell Stimpson.

Dues Schedule

Multiple-Card AFM Member Rebate

Did you know? If you hold membership in three or

more Locals throughout a full calendar year, you are entitled to a rebate from the AFM.

Under the rebate program, membership in a base of two Locals must be established in order for a member to qualify for a rebate. The International Secretary/ Treasurer's office has determined that a musician's membership in his or her "Home Local" and the subsequent Local of longest tenure shall be designated as the two base Locals. The Secretary/Treasurer's office will then rebate the appropriate per capita dues for membership in the third Local and any other Local(s) beyond three to which a member belonged for the entire previous calendar year.

To petition for a Multiple-Card Member Rebate, members should fill out the form and return it to the Secretary/Treasurer's office together with copies of all their paid-up membership cards, receipts of canceled checks for annual dues from all Locals, or a letter from each Local stating that the petitioner was a member in good standing of the Locals for the full year prior. Rebates will be issued after Jan. 1.
