

"Each time a woman stands up for herself, without knowing it possibly, without claiming it, she stands up for all women."

- Maya Angelou

I came across this quote when I was reading about Women's History Month. It struck a chord for me, as I began my career at a time when women playing brass instruments professionally were few and far between and were often considered to be somewhat of a novelty.

I lived through the days of stares, glares, and comments that would make a sailor blush. I lived through the days when women were only hired for jobs with low wages or difficult working conditions.

But I always knew that we all were just people – people fortunate enough to earn a living doing something we had loved since childhood. And for every man who made it difficult for women to establish themselves in our workplace, there was a man who listened, who understood our dilemma, and who wanted to help.

I am so pleased to see the progress that women have made in my lifetime. When Kamala Harris was inaugurated, I wept with joy as I thought of my Mother and my Grandmothers, and how they would have felt seeing a woman ascend to the second highest office in our country.

I am honored to have been elected the first woman President of Local 47 – and I will hold the door open for the many talented and intelligent women to follow.

But what if Maya Angelou's quote had been about musicians? What if we said that whenever one musician stands up for themselves, they are standing up for all musicians?

My guess would be that we would see a degree of unprecedented solidarity – a solidarity that would bring about better wages, better working conditions, better benefits, and perhaps an historic agreement, reached at 3 a.m. on a Friday morning, by a group of exhausted but joyful musicians, standing shoulder to shoulder, joining hands in the realization of what they had achieved.

Officer Reports

Vice President Marc Sazer

It is a pleasure to share good news, and our recent dramatic improvement to our film/TV contracts is great news indeed! We

won a brand-new streaming residual for high budget streaming projects, significant health care increases and pioneering AI protections. This is a tide that will rise all boats here at Local 47, and across our AFM.

Stunningly, the new residual will be paid to musicians through the AFM, rather than through the Film Musicians Secondary Markets Fund. This is a double win for musicians. The work dues revenue will help support future campaigns and the successful administration and enforcement of our contracts. And, it will mean considerably more of the money will go directly to musicians – the film fund pays the employer's share of taxes and admin costs out of our residuals, costing several times more than our work dues. More money for musicians, and a stronger union for us all!

This victory is the result of many factors, prime among them the historic pulling together of our community of musicians. Rank-and-file musicians began meeting and planning over two years ago to lay the groundwork for this success. Our Local 47 hired our organizer, Rahul Neuman has been extraordinarily successful in mentoring us and leading us into a new world of musician-to-musician communication, building out a network that now numbers in the hundreds.

Make no mistake, this victory was not your

grandfather's top-down, old-fashioned union operation. Working as an integrated team with the enlightened leadership of AFM President Tino Gagliardi supported by our leadership team here at Local 47, it was musicians themselves who made this happen, from participating week after week on the picket lines of writers, actors and session singers, to reaching out to leaders of other unions, to building an incredibly successful rally on the doorstep of the companies and more. Just as significantly, our bargaining team included over 100 musicians who attended bargaining sessions, spoke across the table, and flexed muscle through their presence, knowledge and visible determination to achieve their goals. Where do we go from here? The AFM has its eyes set

we concluded negotiations, President Gagliardi met with the CEO and top labor relations rep for Netflix. The path to new signatories will also, ultimately, depend on our participation, so stay tuned. Our Live TV/Videotape agreement was extended until October, which means that we are now beginning our planning process for a broad campaign for that contract with the TV networks. And even this week we are taking early meetings in order to plan to address the historic lack of support for musician's jobs from the California Film/TV tax credit regime. One area of particular interest to AFM President Gagliardi is reaching out to composers, to build bridges, find areas of mutual support, and develop

History Month, let's give a special round of applause to those women who showed up at meetings, on the picket lines and at negotiations. You won a contract of real historical significance for musicians and our union. When we fight, we win!

Most of us recognize the names of some of the more

Morissette and Linda Ronstadt are but a few. During the 1940s, the Second World War provided a real opportunity for female bandleaders and side musicians. In that era of a mostly male military, women finally had their chance at professional careers as

high profile members of our Local. Sheryl Crow, Me-

lissa Etheridge, Germaine Franco, Bobbye Hall, Alanis

instrumentalists while the men were off at war. Our Local 47 database and archives illustrate a rich history of women, some of whose careers receded when the war was over and the men returned to once again dominate the industry.

Do you remember Victoria M. King? She was a singer/ pianist who joined Local 47 in 1943. She led her own group in the 1940s until she married Grady King in 1946 and then performed with his band.

Helen Lorraine Hammond, trumpet, joined Local 47 in

1951 and was a member of the Hormel Girls Caravan,

an outgrowth of the Hormel Drum & Bugle Corps. The corps went on to appear on the radio from 1948-1953 as "Music with the Hormel Girls."

presided over a series of jazz groups, performing and

Longtime Local 47 member Peggy Gilbert, tenor sax,

appearing in Hollywood films like "The Wet Parade" (1932), "Melody for Two" (1937) and "The Great Waltz" (1938). She was also known as an advocate for women jazz musicians, a culture long hostile to female instrumentalists. She formed the Dixie Belles, a band of older women, when she was 69 and played well into her 90s. Perri Lee, organ/piano, joined Local 47 in 1945 and was a member until her death in January of this year.

in the mid-1950s she taught herself to play the organ. She also sang, including a somewhat famous duet with Doris Day in the film "Pillow Talk." She was a featured performer at the Parisian Room in addition to her many recordings with her group, the Perri Lee Trio. Last but not least, let's celebrate Serena Kay Williams! She made history as the first woman officer of Local 47, serving as Secretary and then Secretary/Treasurer

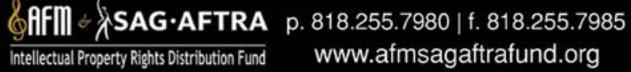

AFM Secures Tentative Agreement with AMPTP, Delivering Historic Wins for Musicians

The American Federation of Musicians of the United States and Canada (AFM) has reached a tentative agreement with the Alliance of Motion Picture and Television Producers (AMPTP) on the Basic Theatrical Motion Picture and Basic Television Motion Picture contracts. The agreement, unanimously recommended by the bargaining committee, represents a significant victory for musicians working in film and television.

"This agreement represents a major win for musicians who have long been under-compensated for their work in the digital age," declared AFM International President and Chief Negotiator Tino Gagliardi. "We have secured historic breakthroughs in streaming residuals, established critical guardrails against the misuse of AI, gained meaningful wage increases and other important gains. This agreement represents a watershed moment for the artists who create the soundtracks for countless film and TV productions."

sicians bargaining unit members for their unwavering commitment to fighting for a contract that fairly compensates them for their invaluable contributions to film and TV and protects them in the ever-changing film and television industry," Gagliardi concluded. "We were not alone in this negotiation, and we were proud to have the full backing of fellow unions: SAG-AFTRA, Writers Guild of America, IATSE, and the Teamsters. It was yet another powerful reminder that when we have solidarity in the labor movement, we can achieve great things. We also would like to thank Carol Lombardini, president of the AMPTP, as well as the AMPTP and its member companies, for helping bring these negotiations to a successful conclusion." The tentative agreement will now be submitted for ratification by the members working under the Basic

Since the release of her 2012 self-titled debut, the electronic music impresario, violinist, dancer, and artist quietly and humbly became one of the 21st century's most innovative stars by clinging to her groundbreaking vision of cinematic violin-driven electronic music.

lion-plus views on YouTube, in 2015 Forbes placed Lindsey at #4 on its yearly YouTube artists list, making her the highest-ranked female. Her headline tours would play to a cumulative audience of over 800,000 people worldwide, and her literary debut "The Only Pirate at the Party," co-written with her sister Brook S. Passey became a New York Times Bestseller. Lindsey's third-studio album "Brave Enough" debuted at #5 on Billboard's Top 200 Album Chart, went on to score the #1 spot on Billboard's year-end Top Dance/ Electronic Album list and earned Stirling a2017 Billboard Music Award for Top Dance/Electronic Album. In 2017 Lindsey released her first ever holiday al-

bum titled" Warmer in the Winter" featuring clas-

sic and original songs. This album was the #1 new

Christmas album of 2017, ahead of pop music heavyweights such as Gwen Stefani and Sia. It was also the best-selling new holiday album and the best performing holiday album on Pandora with over 40 million spins. With such insistent demand coming from her fans, the Christmas album marked another special release in 2018 with a few new songs as well as some Christmas classics. Her single "Carol of the Bells" is still the only instrumental song to ever reach the Top 10 at AC Radio. Lindsey's musical talent and success on YouTube with over billion views also launched a successful career into television. Driven by a strong international fan

base, Lindsey was runner-up on Season 25 of ABC's hit show "Dancing with the Stars" wither partner Mark Ballas and did a stint on NBC's "America's Got Talent" as well. She has continued to build an impressive fan base that stretched across all demographics forging heron path for future young Artists to emulate. Amongst her numerous achievements, Stirling co-headed the U.S. tour with Evanescence which was named as one of Live Nation's 10 best-selling amphitheater tours of the 2018 summer in addition to winning several coveted Music Awards and numerous appearances on the top Billboard ccharts. Her highly anticipated fifth studio album, "Artemis," released in 2019 to critical acclaim and debuted at #1 on the Dance/Electronic Album Chart. In the wake of the cancellation of her 2020 tours due to COVID-19, Lindsey funded and directed a virtual livestream concert that received over 100,00 unique viewers. She started the 2021 year with the release of "Lose You Now," a single featuring Artist/Producer Mako that reflects on loss. In 2022, she released "Snow Waltz," a holiday album that re-imagines the Christmas canon through Lindsey's unique style.

Lindsey Stirling embodies the true spirit of today's independent recording artist whose symbiotic relationship with her fans has led to a worldwide audience filled with positivity. By using her own story to show young adults that confidence in the very thing that makes you unique is the key to success, she continues to be a light in today's entertainment scene and bring her own brand of magic to the many lives she



AFM Local 47 Endorses Adam Schiff for U.S. Senate

On February 6, 2024, the AFM Local 47 Executive Board unanimously moved to endorse Rep. Adam Schiff for U.S. Senate.

Workers' rights have always been a top priority for Schiff, and as Hollywood's representative he has maintained particular focus on the entertainment industry. His founding of the International Creativity and Theft Prevention Caucus has increased awareness and understanding of creative industries, and has helped to create policies at home and abroad that prevent the theft of copyrighted materials. 



Eligibility Eligibility for enrollment in the Health & Welfare

A Participating Employer, or an Employers' Payroll Designee, has entered into a Collective Bargaining Agreement (CBA) with the Union which calls for contributions to come to the Health & Welfare Fund. All contributions must come from a Participating Employer; musicians may not "self-pay" into the Heath & Welfare Fund. Coverage A musician may qualify at one of three levels:

Level A (\$1,500+ contribution), Level B (\$1,200-




