AFM Local 47 Members Celebrate Union PRIDE

Officer Reports

President Stephanie O'Keefe

"...with liberty and justice for all..."



So much of what the AFM, and all labor unions do, can be contained in that one seemingly simple phrase. We are all constantly engaged in a quest for equal, fair, and just treatment for our members.

Unfortunately, it is often quite a struggle — and the attempted exploitation of musicians and other workers can be nothing short of stomach churning.

But we persist because it is the right thing to do and because musicians deserve to be treated and compensated fairly for their creations.

June was an extremely busy month:

- several meetings of the Los Angeles County Federation of Labor Executive Board, on which I serve as a vice-president, including two strike sanction meetings for affiliates
- a meeting of the Valley Economic Alliance, a business networking organization, seeking to expand its activities into the entertainment

community

- a Pride brunch, the very first event held by Queers United in Entertainment, a newly formed organization supporting members of the LGBTQ+ community. Local 47 joins SAG-AFTRA, the WGA, and IATSE in supporting this very important organization
- a meeting with the Western Council of the Entertainment Community Fund (formerly the Actors' Fund), on whose Board I serve
- negotiations with the Open Fist Theatre Company, the Pasadena Symphony, the San Gabriel Valley Music Theatre, the Los Angeles Master Chorale, the Academy of Magical Arts, and the Palm Springs Opera Guild
- working to solve matters related to musicians' employment at the Pantages, Los Angeles Opera, Los Angeles Philharmonic, the Hollywood Bowl Orchestra, and the San Bernardino Symphony

I also attended the new member orientation, followed by the Local 47 Member Mingle, an event that is growing each month. The Member Mingle brings together new members, not yet members, existing members, staff, and officers. Please try to stop by for the next one — I think you'll be glad you did.

We continue working to create a true coalition of entertainment unions in Los Angeles. To that end, on June 22, Local 47 hosted a rally in our parking lot for the The Animation Guild.

I spoke at the rally about our need for solidarity:

"Hello, Animators, the musicians of AFM Local 47 welcome you!

"Since 1928, with the premiere of Steamboat Willie, animators and musicians have together been creating a very special and magical art form. An art form that has delighted and fascinated me my entire life, beginning with my early childhood devotion to Yogi, Boo Boo, and Huckleberry Hound.

"As of this morning, the highest grossing film of 2024 is 'Inside Out 2,' a product of this most magnificent collaboration — animation and music.

"But it is not only in the creation of artistic products

that our collaboration can produce miracles. For when unions come together and align our demands and agendas, nothing is impossible.

"In the last year, we have seen an unprecedented solidarity among the unions in the entertainment industry — a solidarity that took employers and shareholders by surprise, as it unfolded on the streets of Hollywood, right before their eyes.

"When the WGA, and then SAG-AFTRA, and then the AFM all won historical agreements with significant gains, management began to realize that something big had happened.

"And indeed, something big had happened. The creators of the most important product manufactured in this country — a product the rest of the world clamors for — had begun to work together.

"We have discovered the power of solidarity, not just within our own unions, but in the joining together of all the Hollywood unions, as we demand dignity, respect, and the recognition of our true value.

"And so we go forward, shoulder to shoulder, supporting each other, never tiring — for in solidarity lies infinite strength."

Officer Reports

Our Angeleno summer is heating up, and just like that, a whole new season is upon us. Rest assured there's plenty new here at



Local 47 beyond soaring temperatures!

As I write this, we are about to launch "E2," our long-awaited new database system. E2 is more than just a database; it is the breathing heart and soul of all of our work here at the Local, from membership communications and payments to job processing to mailings and more. The process of designing the

system began before my tenure as Vice President, but I have been in charge of the development. And yes, that means that any frustrations you may have should be sent my way.

The new member portal requires every musician to re-register, and we're sending plenty of information out about how to do so. Once in, you should be able to finally get a more accurate and up-to-theminute view of your work history and both past and upcoming payments.

This completely new cloud-based system is far more secure and efficient than our long-standing reliance on in-house hardware and software. We'll be working through the kinks and hiccups over the next few months, so please give us plenty of feedback, but also please grace us with your patience!

Exciting news: The first projects that will be subject to the **new high budget streaming residual** are starting to come in for Local 47 musicians! "Star Trek: Strange New Worlds" season 3 led the way, followed by "Swiped," an upcoming feature film for streaming, and more. The new contract calls for a 26-week free streaming window, so the residuals should start flowing in 2025, but we are on our way. Great congratulations to every single musician who participated in the Fair Share for Musicians campaign and helped kick the door open to an industry standard that had been denied us for so many years.

The next step is to reel back the runaway production that sees scores sent overseas on a regular basis. IATSE, Teamsters 399, LiUNA and others are already calling for increasing the **California Film/TV Tax Credit**, which currently stands at \$330 million annually. This is dwarfed by others; New York will spend over \$700 million this year, Georgia \$1.35 billion, and over a billion from British Columbia. We need our tax dollars to support our music scoring jobs, and we need for California to get back in the game.

Heading into summer, we have been working with an AFM-led steering committee to develop a strong **campaign for the Live TV/Videotape negotiations**, set for this fall. The first round is tentatively scheduled for early September, and we will be rolling out a multi-city survey, and using new technology to expand our Contract Action Team communications webs. Beginning later this month, you will be hearing much more — stay tuned!

Finally, our next **General Membership Meeting** will be held Monday, July 22, at 7:30 p.m. This is your chance to get in-depth information about our Local and our activities, ask questions, and hang with your colleagues. Your participation makes us all stronger!

Member Spotlight

CONDUCTOR/ DIRECTOR MEMBER SINCE 2015

Billen Fox

Maestro Steven Allen Fox is an innovative concert creator, conductor, producer, and composer who has conducted or produced over 100 premieres of new compositions and suites. He received a bachelor's degree in music from Illinois State University,

majoring in music theory and composition, and also has a graduate certificate in film and television scoring from the University of Southern California.

In 2002, Fox founded the Golden State Pops Orchestra where he served as principal conductor for "The Magnificent Movie Poster World of Drew Struzan," the Varése Sarabande 35th Anniversary Concert Gala Series in Los Angeles, and "A Spoonful of Sherman: A Symphonic Concert."

In the summer of 2022, Fox made his debut on the stage of Walt Disney Concert Hall with the Los Angeles Film Orchestra. He has conducted the San Francisco Symphony, Los Angeles Film Orchestra, the Silly Symphonies Orchestra, Hollywood Studio Symphony, Golden State Pops Orchestra, Tenerife Symphony, and the Video Games Live Orchestra.

Special engagements have included "Disney's The Little Mermaid Live in Concert" with the San Francisco Symphony, Guest Conductor for the international film music festival "Fimucité" in Tenerife, Spain, and assistant conductor for the world premieres of "Beauty and the Beast In Concert," "The Little Mermaid Live in Concert," and "Coco Live-to-Film Concert Experience," and also cover conductor to Maestro John Mauceri for "Nightmare Before Christmas Live to Film" at the famed Hollywood Bowl in 2023.

As a composer, Fox has provided scores for multiple feature films and shorts, and has had the opportunity to work with some of the most influential composers and artists in the industry. He helped to win the Independent Film Channel award for animated short for The Artist by Ian Dale. His compositions include a wind quintet, multiple arrangements for concert band, and selections for symphony orchestra.





Maestro Steven Allen Fox receivied the Outstanding Alumni Award from his alma mater, Illinois State University.

On March 24, Fox returned to his alma mater Illinois State University to conduct the premiere of his latest work, "Emotica," with the ISU Symphony Orchestra under director Dr. Glenn Block. On the occasion of the concert, the ISU Director of the School of Music, Dr. Adriana Ransom, surprised Maestro Fox with the Outstanding Alumni Award in recognition of the achievements in his career, and the pride they feel in Maestro Fox representing their institution.

In the program notes for "Emotica," Fox shares how personal experiences led to the concept of the mulitmovement piece which has been a work in progress for him for nearly 24 years: "I enjoy diving into human emotion and psychology, and to communicate a wide array of experiences, such as fear vs. triumph or joy."

Pension

One of the most important benefits your job provides you with is the ability to receive pension benefits when you retire. Even though you can collect Social Security at retirement, your retirement years will be more financially secure if you also receive pension benefits.

Under a collective bargaining agreement with the American Federation of Musicians and its local unions (the "Federation"), or other written agreement acceptable to the Board of Trustees, your employer has agreed to make contributions to a pension fund to provide pension benefits to you and other employees working as musicians (or as employees of the American Federation of Musicians or one of its local unions). The name of the fund is the American Federation of Musicians and Employers' Pension Fund, also referred to as the "Fund." The Fund is operated by the Board of Trustees, which consists of an equal number of Federation Trustees and Employer Trustees.

You should keep in mind that you are not guaranteed a pension just because a pension fund has been established to which your employer contributes. The Fund has rules about how you begin to participate, how can you earn a right to your pension, how much you might receive and when you can start getting payments, what happens to your pension if you die before or after retirement, and many other issues.

IATSE Secures TAs on Area Standards Agreement and Basic Agreement

The Theatrical Stage Employees (IATSE) secured major wins at the close of June with announcements of tentative agreements (TAs) on all issues for the Area Standards Agreement and the Basic Agreement.

The latest agreement between IATSE and the Alliance of Motion Picture and Television Producers (AMPTP) for the studios and streamers means that, if members vote for ratification, it will avert another summer of Hollywood strikes. The Basic Agreement TA comes after more than three months of bargaining and includes provisions like a 7% raise in minimums in the first year, followed by raises of 4% and 3.5%, which matches the terms won by SAG-AFTRA last fall.

Other notable victories include increases to overtime compensation, new protections around artificial intelligence and more. The Area Standards Agreement TA came after two days of talks and includes some identical language like the same scaled wage increases and improved overtime compensation as in the Basic Agreement, as well as wins like Juneteenth added as a holiday and improved bereavement leave.

The remaining Hollywood negotiations that need to be settled before the July 31 contract expiration date are the AMPTP's contract talks with the Teamsters.

Aurelio (Roy) D'Antonio Life Member. Clarinet 7/9/1931 - 5/27/2024

Aurelio (Roy) D'Antonio was at home with his beloved wife, Margaret, when he passed from this earth on May 27 at age 92. He will be remembered as a virtuoso clarinetist, father and grandfather, teacher, friend, bicyclist, and tireless advocate for the underdog as he served in various capacities at Local 47.

Born to Italian Immigrants Giovanni and Colombia D'Antonio on July 9, 1931, Roy grew up in the East Bronx. He studied clarinet with Mr. Caffarelli of the Metropolitan Opera Orchestra, which included spending entire summers at Mr. Caffarelli's house in upstate New York. Those summers were a mixture of working on the farm, clarinet lessons and lots of practicing. By the time he graduated from High School of Music and Art, Roy was already playing clarinet at a professional level; at age 18, with his family's move to Los Angeles, he embarked on his freelance career.

While playing in the Meremblum Junior Symphony, Roy met violinist Joy Lyle. They married in 1954 and had three children: Franklyn, Christopher, and Giovanna.

In 1980, Roy married his second wife Cindy Robertson, and they had two daughters, Aurelia and Barbara. They fondly remember many summers spent in a cabin in Sequoia, absorbing nature.

Roy's remarkable career included playing in the New Orleans Symphony, Glendale Symphony, and Ojai Festival, and touring with both the Metropolitan **Opera National Company and the Los Angeles** Philharmonic. He played in the pit for many Broadway shows, including "My Fair Lady," "Man of La Mancha," "Nicholas Nickleby," "The King and I," and "Phantom of the Opera."

His extensive movie and TV recording credits include "Airplane," "Back to the Future," "Beauty and the Beast," "Big," "Clueless," "Dallas," "Dances With Wolves," "Die Hard," "Dr. Zhivago," "Ferris Bueller's Day Off," "Flipper," "Ghostbusters," "Gremlins," "Godfather" I, II, & III, "Grand Prix," "The Hunt for Red October," "Indiana Jones," "It's a Mad, Mad, Mad, Mad World," "JFK," "The Karate Kid," "Star Trek," "Taps," and "The X-Files."

He performed as principal clarinetist with every major ballet company that came through Los Angeles (American, German, Russian, English, Australian, Polish, French), and played with the RCA (chamber) orchestra on the last recordings of Jascha Heifetz. Perhaps most memorably, he recorded "L'Histoire du Soldat" with Igor Stravinsky conducting.

Roy is remembered by his students as an unusually passionate, demanding, and generous teacher. Teaching clarinet was not just a one-hour-a-week job for him. It was a commitment to tough love, as he guided his students along the challenging path to artistry. No amount of time or energy was too much for Roy, and he expected the same from his students. Roy loved to cook, and his students were frequent dinner guests.

Another passion for Roy was bike riding, and he covered thousands of miles on Mulholland Highway and other local mountain roads, sometimes with his sons and grandsons, and occasionally with those few of his students who were up to it.

Roy spent the last 30 years with his third wife, Margaret Wennberg, who was a longtime friend. He passed away on Memorial Day, and Margaret joined him 11 days later.

He is survived by sons Franklyn and Christopher, and daughters Giovanna (Gigi), Aurelia, and Barbara. He is also survived by seven grandchildren: Jonathan, Timothy, Kimberly, Matthew, Alex, Charlie, and Sally; and five great-grandchildren: Katie, Lauren, Violet, Charlie, and Charlotte.

Roy D'Antonio never did anything half-way. He was passionate about music, love for his family, his ideals in advocating at the Musicians' Union, bicycling, and cooking. His intensity for life was an inspiration to all who knew him.

Dues Schedule

Annual and Semi-Annual Membership Dues for Regular, Life and Inactive Life Members are due January 1 of each year. Payment must be received by March 31 (three-month grace period) to avoid suspension. If not paid by this date, a \$75 reinstatement fee will be assessed. Payment must be paid by June 30 to avoid expulsion.

Likewise, Semi-Annual Membership Dues for Regular Members are due **July 1** and must be received by **September 30** (three-month grace period) to avoid suspension. If not paid by this date, a \$75 reinstatement fee will be assessed. **Payment must be paid by December 31 to avoid expulsion.**

Please note: Inactive Life Members do not have all of the same rights as privileges as Regular and Life Members, such as the right to vote in Local elections. Please review the AFM Local 47 Bylaws for complete information.

> Notice From the Executive Board: Work Dues Delinquency and Suspension

1) Local 47 members whose work dues delinquency exceeds \$500 shall be suspended; and

2) Non-Local 47 members whose work dues delinquency exceeds \$500 shall be referred to the IEB as provided in the AFM Bylaws.

In order to reinstate membership, a \$75 reinstatement fee will be assessed.

Resignation Policy

In order to resign in good standing, you must submit your written request to Local 47 before your membership is suspended. Though dues are due Jan. 1 and July 1, current grace periods extend to March 31 and Sept. 30, respectively; suspensions are posted April 1 and Oct. 1.

In addition to membership dues, all other financial obligations, Local and International, must be paid prior to resignation. Your letter of resignation will be presented at the following Executive Board meeting and a written response will be mailed to you. If you wait, you will be required to pay another half year's dues and/or clearance fee.

Multiple-Card AFM Member Rebate

Did you know? If you hold membership in three or more Locals throughout a full calendar year, you are entitled to a rebate from the AFM.

Under the rebate program, membership in a base of two Locals must be established in order for a member to qualify for a rebate. The International Secretary/ Treasurer's office has determined that a musician's membership in his or her "Home Local" and the subsequent Local of longest tenure shall be designated as the two base Locals. The Secretary/Treasurer's office will then rebate the appropriate per capita dues for membership in the third Local and any other Local(s) beyond three to which a member belonged for the entire previous calendar year.

To petition for a Multiple-Card Member Rebate, members should fill out the form and return it to the Secretary/Treasurer's office together with copies of all their paid-up membership cards, receipts of canceled checks for annual dues from all Locals, or a letter from each Local stating that the petitioner was a member in good standing of the Locals for the full year prior. Rebates will be issued after Jan. 1.
