#### **Officer Reports**

President Stephanie O'Keefe

This month, we pause to salute working people and to reflect on organized labor and what it means to us.

The word organize comes from the Latin word, organum, which means an instrument or tool. Organizing — the act of joining people together to pursue a common cause — is the fundamental tool of unionism.

But are musicians laborers? Are we actually a part of the labor movement? What does it mean to organize and why should we care?

While we are artists, often beginning the pursuit of our craft in childhood, when we go to work, there is absolutely no question that our employers think of us as labor. As any of you who have been involved in a contract negotiation know, employers seek to pay the least for the most and will often argue that our demands for fair wages and benefits are unreasonable and threatening to the survival of their enterprise.

Recently, I heard an employer refer to the process of hiring musicians for an orchestra as "staffing." I was horrified, but perhaps what was most astonishing about this remark was the lack of any discomfort or embarrassment at referring to skilled artists in this fashion.

Unions are the antidote to this kind of thinking. And organizing is what creates unions, grows union membership, and keeps unions strong.

At Local 47, we are currently involved in a national contract campaign for the Live Television Agreement, as well as eleven different negotiations for local collective bargaining agreements. We are exploring organizing opportunities for work that is not yet covered by an AFM agreement and continue to carefully administer and enforce our existing contracts.

We actively support other entertainment unions and participate in the County and State Federations of Labor. And we are beginning to work on legislative campaigns to ensure additional scoring work and to address the looming threat of artificial intelligence.

All of this activity contributes to my number one goal: a world in which professional musicians are respected and are able to prosper and live lives of dignity.

#### **Officer Reports**

# Vice President Marc Sazer

During the past few months we have been working tirelessly to prepare for the Live TV/Videotape negotiations between our



AFM and the three "nets": ABC, CBS and NBC. Much of the work has been behind the scenes, working with our Local 47 Organizer Rahul Neuman and the AFM organizing team led by Gabe Kristal to bring musicians together, developing and distributing a survey of the affected musicians, and working with a variety of AFM committees to develop proposals. The stakes are high — and by now familiar: streaming rights and payment, AI rights and protections, health care and more.

The first round of negotiations is taking place in

New York the week after Labor Day, and Local 47 President O'Keefe, Local 47 Rank-and-File Representative Caleb Vaughn-Jones and I (in my role as President of RMA) will be attending. We have all been participating in the AFM steering committee, and both Caleb and I have participated in the AI committee, as well as the streaming committee.

We'll have plenty to report when we return, so stay tuned!

I'm very excited about our unfolding **legislative agenda**! When I say "our" I mean to cast a wide net; from rank-and-file musicians, player conferences, our Local 47 and the AFM, we are planning to grow our political clout in Sacramento and at the Federal level in both the U.S. and Canada. Our AFM administration has just hired a new, high-powered Legislative Director in Washington, D.C. and here at Local 47 we are working with AFM President Gagliardi and the administration to plan legislative moves in Sacramento for next year.

This AFM administration recognizes that **California is a legislative leader** for the whole country, and is willing to spend time and resources helping grow out power with the entertainment industry union community, and California legislature.

Our goals are lofty, and promising. It is long overdue for our **film/TV music jobs** to benefit from the hundreds of millions of tax dollars given by California to film/TV studios to produce their projects, and from the billions that are given them by Georgia, New York, Louisiana, British Columbia, Ontario and more.

We also have legislative language prepared to achieve **AI protections** for musicians both here in California and ultimately at the federal level. In Congress, we will be working in the coming year to finally pass the American Music Fairness Act, requiring big broadcasters to pay musicians for the use of their music and unlocking millions of dollars in overseas royalties for U.S. musicians.

National Hispanic Heritage Month

I love L.A.! One of the characteristics I love most about our region is our rich, deep and growing diversity. Beginning in the middle of the month, September is National Hispanic Heritage Month across the United States. Our sprawling metropolis was founded as a Spanish-speaking town in 1784 by the original *Pobladores*, 44 settlers accompanied by four soldiers. We've gone through a bit of growth since then, but Los Angeles currently has the largest Spanish-speaking population outside Latin America or Spain. During the course of September, I'm confident we will all be treated to programs and information about the vast and diverse contributions made by notable individuals of Hispanic descent. I take particular pleasure and pride in living in a region filled with non-famous working people, waiters, musicians, carpenters, dancers, grocery store clerks, actors and more, who together help make our communities strong, rich — and, for a foodie like me, delicious! *Me gusta y me interese comida de* todo el mundo, pero los tacos al pastor, salsa de chile habanero hecho a mano, los moles, y todo más de la comida Mexicana me encanta. **¡Te amo, Los Ángeles!**

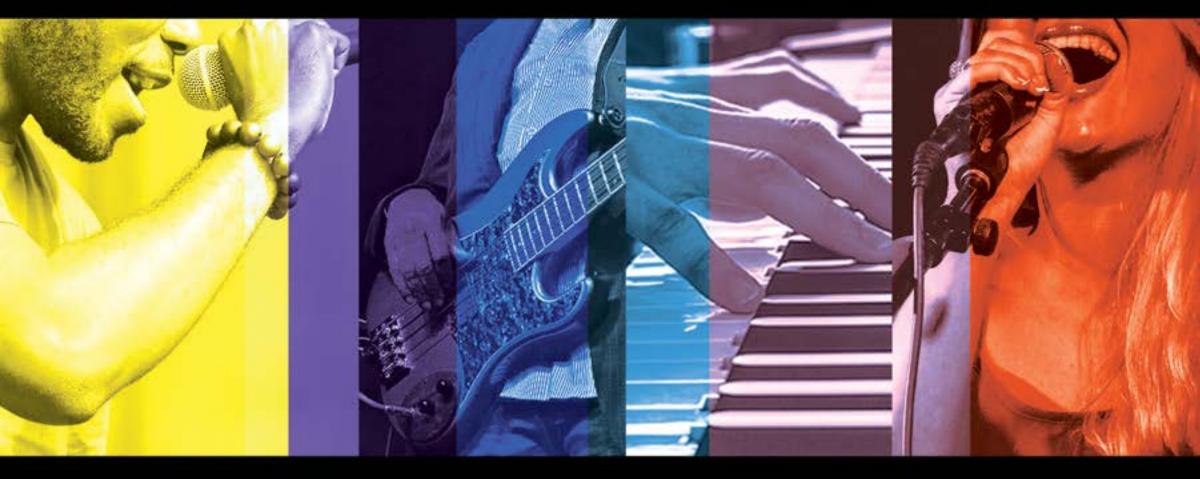




Exploring Music's Pivotal Role in the Labor Movement

"A singing army is a winning army, and a singing labor movement cannot be defeated." – John L. Lewis, President, **Congress of Industrial Organizations** 

Labor Day is a celebration of all workers' great contributions to our country, and offers an opportunity to not only reflect upon the hard work we do in our craft as musicians, but also on the significant impact music has had within the labor movement.

Music is a powerful force which is deeply intertwined with labor. It has long been — and continues to be used in songs about and for work, as well as a form of protest, and as a way of joining people together. Protest songs were often set to popular tunes of the time, a practice still in common use today. A popular example of this is "Solidarity Forever" written by Ralph Chapin and sung to the tune of "Battle Hymn of the Republic" written by abolitionist writer Julia Ward Howe during the American Civil War. Another example is "In the Good Old Picket Line" sung to the tune of "In the Good Old Summer Time" (music by George Evans and lyrics by Ren Shields).

The labor movement also shares deep roots with folk music, songs shared orally that comment on national cultures. In the mid-twentieth century, a revival of the folk tradition carried powerful political messages through a populace, often commenting on the state of labor workers and unions, as exemplified in songs like "Union Burying Ground" by preeminent folk artist Woody Guthrie. Many such folk musicians reached fame supporting union efforts at rallies and gatherings nationwide, integrating music into the fabric of the labor movement irrevocably.

Members of the farmworkers' cultural ensemble, El Teatro Campesino, created Spanish-language versions of well-known songs from both established labor unions and the civil rights movement, which they sang in the fields and on picket lines as part of their fledgling union's efforts to organize laborers in the vineyards surrounding Delano, California. They did so at the urging of Cesar Chavez himself, who understood in his bones the vital role music played in the social life of his people. The song "No Nos *Moverán"* ("We Shall Not Be Moved") became the leading fight song of the farmworkers' movement.





UFW leader Dolores Huerta recalls the significance of this song, and of music more generally, to the farmworker struggle. "We sang 'No Nos Moverán' every day... because we were on those picket lines from early morning 'til late in the evening and we had to keep our spirits up on the picket lines. And one way that we kept our spirits up... was to sing these songs... You know, when you're talking about a strike going on for five years — that was a long time to be on strike! Music was extremely important to keep people from getting discouraged. 'No Nos *Moverán'* symbolized the spirit that we had and that we needed to maintain. To keep people strong and let them know that eventually we're going to win as long as we don't give up."

Labor songs continue to serve as a tool to unite people and to influence thinking about work and the worker.

#### **Member Spotlight**

A CUTARIST / VOCALIST MEMBER SINCE 2003

Songwriter. Activist. Rock star. Woman. Champion. Mother. Nine-time Grammy winner Sheryl Crow is many things, but at the core, she remains a creative spirit channeling her talents into music that lifts people up, brings them together, and speaks to the truths on the horizon.

Crow's is a career beyond dreams, with songs that defined the third wave of feminism, a rockist's ability to sweep the pop charts without losing any edge and enough wide-open Midwestern joy to captivate the world. Her first nine studio albums have sold 35 million copies worldwide; seven charted in the Top 10, and five were certified for Multi-Platinum sales. "Sheryl," a Showtime documentary about her life and career, was released to critical acclaim in 2022. And in 2023, Crow garnered another milestone accolade, with her induction into the Rock and Roll Hall Of Fame.

Crow has been feted by a new generation of singersongwriters who have covered her songs and talked about her influence, including Olivia Rodrigo, H.E.R, Haim, Maren Morris, Lorde, Sasami, Best Coast, and Brandi Carlile. "The passion and ability of our young people to dig deep and express themselves energizes and encourages me endlessly," Crow says. "It thrills me to see their passion and will to change the world."

Crow is known as well for her passionate support of multiple charities, including The Breast Cancer Research Foundation, The World Food Program, Feeding America, ADOPT A CLASSROOM, the Elton John AIDS Foundation, MusiCares, Pelotonia, the Delta Children's Home and many other worthy causes.





#### In the Studio




AFM Local 47 was proud to partner with Joy Music House and the Alliance of Women Film Composers last month on their 2<sup>nd</sup> annual Score Production Workshop, where we hosted the studio prep day in our rehearsal rooms.

## **Joy Music House Score Production Workshop Celebrates Second Year**

From August 23-25, Joy Music House presented its in-person studio weekend of the 2<sup>nd</sup> Annual Los Angeles Score Production Workshop, co-sponsored by the Alliance for Women Film Composers (AWFC), which teaches composers how to produce a successful live scoring session.

"We cover both the intricacies of the actual studio days working with musicians, as well as writing for real musicians, and appropriately orchestrating and copying music so it is both playable and enjoyable for musicians to perform," said Joy Music House CEO Catherine Joy. "Composer participants have a month of zoom classes which culminate with the in-person studio weekend, this year at EastWest Studios."

Joy Music House and AWFC proudly partnered with AFM Local 47 on this workshop, and the studio prep day was held at the Local's rehearsal space. AWFC co-presidents Heather McIntosh and Allyson Newman spoke with the composers for the first hour of the prep session. Workshop musicians were contracted by Lisa Liu who, along with the brass/woodwinds leader Preston Shephard, were present on the prep day to look over (and even play over) music with the composers to make sure any potential challenges were discussed and strategized before the recording days.

"The first day in the studio we worked with brass and woodwinds, and the following day with strings," Joy said. "On Sunday we had the privilege of AFM Local 47 President Stephanie O'Keefe visiting and meeting with the composers at EastWest Studios and speaking with them about the AFM and the realities of the live scoring landscape today. She spoke both of the challenges and the joys of live scoring, and how by doing this very workshop they are part of keeping the art of live scoring alive. Stephanie was also with us for the inaugural workshop last year at Silent Zoo studios. Joy Music House is so grateful for the ongoing support and collaboration with Stephanie and AFM Local 47."

"This is why we are training composers to work with the brilliant musicians we have in our community and hopefully igniting in them the same passion we have for live scoring sessions. ## **'Star Wars' Meets NASA:** Hollywood Studio Symphony Releases 'Across the Stars'

The most romantic cue from John Williams' "Star Wars" universe receives a new take in honor of the NASA Chandra X-Ray Observatory's 25<sup>th</sup> Anniversary.



The recording of "Across the Stars (Love Theme from Star Wars: Episode II)" by the Hollywood Studio Symphony was led by producer Christian Amonson and conducted by Raphaela Lacerda on the Streisand Scoring Stage at Sony Pictures in Culver City on June 26 during a special invite-only recording session accompanied by projections from the Chandra on 12foot screens. The recording (audio and video) was released on August 26, the same day the satellite returned its first image from "across the stars" back to Earth.



AFM Local 47 President Stephanie O'Keefe was invited to the session and had this to say: "This was a very exciting project and I am so pleased that Local 47 musicians contributed their talents to making it happen."



About the piece, composer John Williams writes: "This installment of Mr. Lucas' far-reaching saga offers the unusual and very welcome opportunity to compose a love theme... 'Across the Stars' suggests the timelessness of love-eternal while dropping the hint that our lovers' knot might be ill-fated and 'starcrossed.'"

The Hollywood Studio Symphony is formed by members of the American Federation of Musicians Local 47. AFM Local 47 members are high-level studio musicians, work on major motion pictures and television, tour throughout the world, and are members of premiere orchestras and symphonies including the LA Philharmonic, LA Opera, Pacific Symphony, Hollywood Bowl Orchestra and more. Local 47 members — arrangers, composers, producers, contractors, engineers, and freelance musicians — are regarded as some of the very best in the world, and are responsible for the blockbuster scores recorded in L.A. The orchestra was contracted by Lisa Liu, who also served as concertmaster.



The new work featured some familiar players in the "Star Wars" universe. "The piece begins with harp, and I wanted two — Koni Choi and Jillian Lopez to create a symmetrical rhythmic foundation, followed by a heart-melting oboe solo, played by Claire Brazeau," said Amonson. "The piece ends with an English Horn, played by John Winstead, along with strings that fade into nothing. It's gorgeous. On the piano is Harlan Hodges, the composer for 'Star Wars: Galaxy's Edge' — how cool is that? And the trumpet section has three members who used to serve in the Marine Band, like me: Tom Hooten (principal trumpet, LA Phil, and Thornton professor), Jeffrey Strong (3<sup>rd</sup> trumpet, LA Phil), and Jennifer Marrotta (Thornton professor and frequent sub with the LA Phil). Thanks to Local 47 for bringing us all back together again."

## About Chandra

The Chandra X-Ray Observatory is a NASA mission centered on the Chandra X-Ray satellite telescope, one of two remaining "Great Observatories" (Chandra and Hubble). It allows NASA to detect cosmic x-rays that cannot reach the surface of the earth. Chandra is 100 times more sensitive than any previous X-ray telescope and is able to detect sources 20 times fainter than before.

The telescope took over 20 years to design and build, was launched aboard the Space Shuttle Columbia on July 23, 1999, and was the largest payload ever carried. It was the first NASA mission led by a woman: Col. Eileen Collins. And a woman, Col. Cady Coleman was responsible for deployment in orbit.

Once deployed, astronomers directed the Observatory to point across the stars towards Cassiopeia A, 11 thousand light years away. It was Chandra's official "First Light" image, released August 26, 1999. The image was the first ever captured of a neutron star, seen as the center of Cass. A, amidst the intricate pattern of the expanding debris from the shattered star. View the Chandra photo album <u>here</u>.



## Entertainment Unions Support Striking SAG-AFTRA Video Game Workers

The actors who breathe life into the video games you love are facing an existential threat — and that's why they have gone on strike.

AFM Local 47 musicians and leadership joined our SAG-AFTRA colleagues at two picket line actions in Burbank last month as actors are taking a stand against the Video Game industry to fight for A.I. protections, improved wages, and fair treatment and protections.

SAG-AFTRA members who perform in video games went on strike against all video game companies signed to the Interactive Media Agreement, effective 12:01 a.m. on July 26. The vote to strike comes after more than a year and a half of negotiations without a deal.

Although agreements have been reached on many issues important to SAG-AFTRA members, the employers refuse to plainly affirm, in clear and enforceable language, that they will protect all performers covered by this contract in their A.I. language.

Two days prior to the kickoff rally, the American Federation of Musicians (AFM), Directors Guild of America (DGA), International Alliance of Theatrical Stage Employees (IATSE), International Brotherhood of Electrical Workers Local 40 (IBEW), International Brotherhood of Teamsters Local 399 (IBT), Laborers International Union of North America Local 724 (LiUNA!), Operating Plasterers & Cement Masons International Association (OPCMIA) Local 755, United Association Plumbers Local 78 (UA), Writers Guild of America East (WGAE), and Writers Guild of America West (WGAW) issued the following joint statement of solidarity with striking members of the Screen Actors Guild-American Federation of Television and Radio Artists (SAG-AFTRA) who work on video games:

"For more than 18 months, the SAG-AFTRA Interactive Media Agreement Negotiating Committee has worked in good faith to reach a deal on a new contract with 10 video game producing companies. Despite the committee's efforts, these employers who generate billions of dollars in annual profit from 3.2 billion active gamers worldwide – failed to recognize the rights of workers to be protected against the unconstrained rise of artificial intelligence. These workers have made the difficult choice to strike as they fight for basic AI protections, and we stand with them in solidarity. Our unions understand the need to fight back against the threat of AI. We call on these video game companies to acknowledge the contributions of these performers, and to work toward a future where their work is valued, and their labor cannot be replaced by technology."

## Labor Stands With Animation During Contract Negotiations

AFM members and leadership from Los Angeles 47 and Orange County 7 joined thousands of industry union members turned out on Saturday, August 10, to support the Animation Guild (TAG) IATSE Local 839 by attending the "Stand With Animation Contract Negotiations Kickoff Rally," held at IATSE Local 80 in Burbank.

The following week animators began round 1 of bargaining with the Alliance of Motion Picture and Television Producers (AMPTP), which concluded their first week of negotiations without reaching an agreement.

The union's proposals addressed critical issues facing the animation industry and TAG members that included AI protections, improving streaming provisions, craft-specific issues, and job security. The producers then shared their proposals with the Union's bargaining team.

In a strong show of solidarity, entertainment unions including the American Federation of Musicians, Directors Guild of America, International Alliance of Theatrical Stage Employees (IATSE), International Brotherhood of Electrical Workers Local 40 (IBEW), International Brotherhood of Teamsters Local 399, Laborers International Union of North America Local 724 (LiUNA!), Operating Plasterers & Cement Masons International Association (OPCMIA) Local 755, Screen Actors Guild-American Federation of Television and Radio Artists (SAG-AFTRA), United Association Plumbers Local 78 (UA), Writers Guild of America East, and Writers Guild of America West issued the following joint statement of solidarity with the Animation Guild:

"We stand with the members of TAG as they seek contractual provisions that set fair wages and working conditions, prevent overwork, and safeguard workers from the impact of artificial intelligence. TAG negotiates independently of IATSE's West Coast Studio Locals to address the unique priorities of animation workers, and they do so with our full collective backing. We also call on the AMPTP to negotiate in good faith, show you value and respect your animation workers, and make meaningful moves to address their specific priorities."

TAG reports they are committed to returning to the table on September 16 to focus on issues decimating the animation industry. Though negotiations have moved more slowly than anticipated, progress is being made, and so the Negotiations Committee voted to extend the contract through September 20 to allow for the second week of discussions.



copayments, coinsurance, and some other expenses, you can lower your overall health care costs.

## **Family and Medical Leave Act**

Under the Family and Medical Leave Act of 1993 (FMLA), you may be entitled to family or medical leave. If you are eligible and elect to take FMLA leave, your coverage under the Plan will continue with no interruption of active employment until the earlier of the end of such leave, or the date you notify your employer you do not intend to return to work at the end of the FMLA leave.

Continued active participation in the Plan while on FMLA leave will be at your option. Employers are responsible for funding the same portion of the employee's premium that they paid before FMLA leave. Employees are responsible for funding the same portion of the premium that they paid before the FMLA leave. If you elect not to continue your benefits during the FMLA leave, your coverage will be reinstated without regard to any pre-existing condition limitation on your return to active working status on or before the end of the FMLA leave.

A leave taken under FMLA does not constitute a COBRA qualifying event unless the employee fails to return to work at the end of the FMLA leave. In that case, the last day of FMLA leave would be the qualifying event date for COBRA. You must contact your employer to determine your eligibility for FMLA leave.

## HIPAA **Health Insurance Portability and Accountability Act** of 1996

The intent of the HIPAA legislation is to improve the availability and portability of health coverage by:

Restricting preexisting condition exclusions and limitations;

Providing credit for prior coverage to reduce or eliminate preexisting condition limitations;

Providing new rights to enroll in plans in situations when other coverage is lost;

Prohibiting discrimination on the basis of health status; and,

Guaranteeing the availability and renewability of health coverage for small employers

Contract negotiations for Teamsters Local 399 and Teamsters Local 817 with the Alliance of Motion Picture and Television Producers (AMPTP) began August 26 in Los Angeles for California and New York Casting Directors, Associate Casting Directors and newly organized Casting Assistants.

The casting department plays a crucial role in every film and television production by balancing both the creative and logistical aspects of securing actors for the necessary roles. Overall, the casting department is essential in shaping the narrative of a production while also managing schedules and negotiating deals on behalf of the selected talent.

Last year, Casting professionals stood with the WGA and SAG-AFTRA during their dual strikes. This year our Casting Community stood with the Hollywood crew as they fought for a fair contract.

"We call on the AMPTP to negotiate in good faith, make meaningful moves on their core priorities and respect the art and craft of Casting Teamsters."



## **Dues Schedule**

## Multiple-Card AFM Member Rebate

Did you know? If you hold membership in three or more Locals throughout a full calendar year, you are entitled to a rebate from the AFM.

Under the rebate program, membership in a base of two Locals must be established in order for a member to qualify for a rebate. The International Secretary/ Treasurer's office has determined that a musician's membership in his or her "Home Local" and the subsequent Local of longest tenure shall be designated as the two base Locals. The Secretary/Treasurer's office will then rebate the appropriate per capita dues for membership in the third Local and any other Local(s) beyond three to which a member belonged for the entire previous calendar year.

To petition for a Multiple-Card Member Rebate, members should fill out the form and return it to the Secretary/Treasurer's office together with copies of all their paid-up membership cards, receipts of canceled checks for annual dues from all Locals, or a letter from each Local stating that the petitioner was a member in good standing of the Locals for the full year prior. Rebates will be issued after Jan. 1.
