



#### **Officer Reports**

President Stephanie O'Keefe

"To stop the flow of music would be like the stopping of time itself, incredible and inconceivable."

Last month, as we headed into Thanksgiving, I wrote about gratitude and appreciation.

Now, there are holidays approaching which celebrate miracles. And so it seems fitting to address what I

have come to think of as "the great paradox."

Well before I ran for office, when I was playing professionally, I reminded myself — sometimes on a daily basis — that the value of what I and my colleagues were creating had long been established. For thousands of years, humans have created instruments, written songs, and performed music. Music is an integral part of all the important moments and ceremonies in every culture found on Earth. Music is performed at events of great joy, great sorrow, and official business. Music is performed as soldiers are sent to war, and again to bury the casualties of those cruel and senseless endeavors.

My mantra during my playing years was, "I will not argue with someone about the value of what I do. That has been known for thousands of years. My job is simply to make a living doing it."

But then there is the paradox...

Music is utterly ubiquitous — it permeates every aspect of daily life, for virtually everyone on Earth. A sweeping statement, perhaps, but an accurate one. Yet while music is so highly valued, the people who create it are often disregarded.

My daily life now revolves around this paradox.

Each day, I stand before employers, reminding them, sometimes in a friendly manner, sometimes more forcefully, that MUSICIANS create the music they hold so dear. And that without those musicians who have devoted their lives to their craft — the world would be a silent and somber place, indeed.

Frankly, there is no amount of money too great to offset the unthinkable — a world without music.

And yet all we ask is compensation that allows us to live lives of dignity, while continuing to create that which is so important to us and to the world.

Sometimes, I find myself wishing that those who devalue musicians would be forced to spend a day without any music, whatsoever. No Spotify, no radio, no concerts or theatrical performances. Television, movies, and video games, all without music of any kind. Perhaps — at least in my fantasy — those who devalue us would gain a new appreciation for who we are and what we do.

But in the meantime, I remind myself that what each of you do, daily, is truly miraculous.

#### **Officer Reports**

### Vice President Marc Sazer

We are launching a new vision of Local 47, a growing, dynamic organizing union for the 21<sup>st</sup> century!



Local 47 has had a number of labor organizers in the past. Like the wider labor movement, we are evolving to recognize the **need to invest in organizing** in order to achieve the goals we set out, whether it be winning industry-standard streaming residuals in both live TV/videotape and film and TV film, working with legislators in Washington, Sacramento and City Hall for fairness in employment from our tax dollars, or improving the contract for the Pasadena Symphony. Pulling our community of musicians together for success in all these areas and more — requires an ongoing commitment.

The **AFL-CIO adopted this commitment** into their Constitution: "We will organize workers into unions allied by common purposes and mutual reliance. We will recruit generations of organizers, amass resources to sustain their efforts and inspire workers to achieve dignity and security through organization and collective bargaining. We will generate broad understanding of the necessity of organizing among our members, our leaders and all unorganized workers."

Likewise, this was an overarching theme of the last Convention of the **American Federation of Musicians**, even leading to the successful passage of a Resolution, now in the AFM Bylaws, that allow the International Executive Board to exceed budgeted expenses only and especially for organizing: "... shall not exceed the projected annual income for that year, with the exception that any projected expenses related to Organizing and Education may be offset by drawing from the AFM's unrestricted cash reserves."

In November, AFM **President Tino Gagliardi** and **AFM Director of Organizing Gabe Kristal** met with our Local 47 Officers and subsequently our Executive Board, carrying a **vision of forward-looking growth and progress** for Local 47 based on a commitment to organizing.

**Your Executive Board voted unanimously** to propose an amendment to our Local 47 bylaws creating a new Organizing Division, led by a Director of Organizing, who can help lead our Local into a new future of growth and progress. This amendment will come before the membership at our January General Membership Meeting. That meeting will be at 7:30 p.m. on January 27, and we are hoping to be able to hold the meeting in a hybrid in-person and online format. Please plan on attending so that you can help chart the course to the future for our Local!

But the Executive Board realized that **the time is now**. We have moved ahead with an ad for a Director of Organizing, looking for an individual with a proven track record of launching campaigns, building them, and seeing them through to successful conclusion. The AFM will give us full assistance in the interview process, and we hope to bring a wonderful candidate to the Executive Board soon.

With the holidays upon us, I'm thinking about all of us who have had fewer jobs, fewer health care and pension contributions, and emptier schedules over the past couple of years. Sitting here inside the building at Local 47 in my still-new role as a full time officer I focus every day on the challenges facing most musicians in the dramatically constricted environment we are currently facing, following the pandemic, multiple strikes and an epidemic of runaway production.

We will also be facing headwinds as a union under a new administration in Washington that has laid out a platform of undermining union rights across the board.

The answer to all of these challenges is for us to **pull together, gather together, and stick together**. Our new organizing-forward approach will make a difference, slowly but surely. I hope to see each of you at our January 27, 2025 General membership Meeting. And I wish each and every one of us a joyous, healthy holiday season filled with love and music. (And good food!)

#### **Officer Reports**

### Secretary/Treasurer Gail Kruvand

Another year is drawing to a close, and while we are busy preparing for the end of our fiscal year we are also looking towards the future. Local 47 is excited to commit to becoming an organizing union to



grow a more engaged membership. For too many years the union movement in the U.S. was focused on a business unionism with top-down hierarchies of union leaders managing negotiations and other critical functions without input from the rank-andfile members. Unions of all types, public and private, have seen the decline in membership numbers since the 1950s and recognized that "Organize Or Die" isn't just a slogan. At Local 47 we are renewing our commitment to an organizing approach with member driven campaigns taking center stage. We're excited to hire a Director of Organizing and grow a better future for musicians.

Our 2025 budget process will present challenges as our revenues continue to lag behind what we expected in 2024. We have managed to contain costs but know that without growing the abundance of work in Los Angeles, we will continue to see diminished membership and revenues. Organize Or Die! We're investing in our future by investing in organizing.

I urge you to attend our next General Membership Meeting on Monday, January 27, at 7:30 p.m. at the Local. There will be two bylaw amendments for

your consideration as well as financial and annual Musicians' Club reports. Congratulations to you who read our communications and participate in membership meetings. Our union thrives on your participation.

If you haven't already, please log in to your account in our newly revamped system, Ensemble 2.0. Follow the instructions on our website at <u>afm47.org/e2</u>. Contact <u>E2Help@afm47.org</u> with any questions or if you have trouble logging in to your account.

Annual membership renewal invoices will be in the mail this week and you will have until March 31 to remit your payment. Please do it sooner than later as it costs our Local resources, financial and staff time if your membership is suspended for non-payment of dues. We have increased the suggested donation to the Relief Fund and Political Action Committee to \$5. I hope that you will make a donation if you are able as both are funded by your generous contributions.

#### **Member Spotlight**



Full rests are rare for Germaine Franco. As a Grammywinning and Oscar-nominated composer, she's been in constant motion.

Her extensive resume, coupled with her curiosity, and inventiveness, has made her a trailblazer. Franco was the first Latina to win a Grammy for Best Score Soundtrack for Visual Media with her score for "Encanto," and the first to receive the Annie Award for Outstanding Achievement for Music in an Animated Feature with "Coco" in 2018.

In addition, "Encanto" received an Academy Award nomination for Best Original Score, an SCL Award for Outstanding Original Score for a Studio Film, an Annie Award for Best Music in a Feature, a Billboard Music Award, and a World Soundtrack Awards nomination for Film Composer of the Year in 2022.

Her work has been performed by the Chicago Philharmonic, National Symphony Orchestra, St. Louis Symphony Orchestra, Cincinnati Pops Orchestra, and Los Angeles Master Chorale, among others.

Beyond the screen, Franco is active in various philanthropic and music education endeavors. She is a board member with the Neighborhood Music School in Boyle Heights and has been a featured speaker or guest artist at many prestigious organizations including UCLA, USC, the Juilliard School, Brown, Northwestern University, Emerson College, The Academy of Motion Picture Arts and Sciences, Sundance Film Festival, Databricks, and Shipt.

Franco holds both a bachelor's and master's degree in music from Rice University's Shepherd School of Music. Her master teachers include John Ashton Thomas, John Powell, Emil Richards, Phil Kraus, Buster Bailey, and Luis Conte.


# Are you interested in presenting a FREE and open to the public CONCERT?

### **Resolution Adopted at October General Membership Meeting**

Thank you to all who attended our Fall General Membership Meeting on Monday, October 28. Though we did not reach a quorum, several lively discussions were held by those in attendance.

The meeting kicked off with a wonderful presentation from LA Federation of Labor Lead Organizer Miguel Cruz on the importance of Measure A, which we are happy to say passed in the November election by an overwhelming majority.

Next, a Resolution to amend the Bylaws was presented concerning the scheduling of quarterly General Membership Meetings. Due to the lack of quorum, a Special Executive Board meeting was held so that the Board could act upon the Resolution, which was recommended for a YES vote by the Legislative Committee. Several members asked questions and offered various opinions, suggestions and recommendations. Of the seven Board members present, all unanimously voted in favor to pass the Resolution.





### **AFM 47 Life Member Clint** Eastwood Releases 40<sup>th</sup> Film, **'Juror #2'**

"Juror #2," the 40<sup>th</sup> film directed by living legend, AFM Local 47 Life Member Clint Eastwood, is a legal thriller written by Jonathan Abrams and starring Nicholas Hoult, Toni Collette, J. K. Simmons, and Kiefer Sutherland.

The musical score was recorded on the famed Warner Bros. Scoring Stage in April. The AFM Local 47 orchestra was led by member Pete Anthony.

The film had its world premiere at AFI Fest on October 27, and on November 1 was given an extremely limited U.S. release in a puzzling move by Warner Bros. Pictures, being distributed to just 50 theaters nationwide. It will move to Warner Bros. Discovery's Max streaming service on December 20.

Eastwood, 94, has directed, starred in, or produced — and sometimes all three — 46 films for Warner Bros. since 1971.

"Juror #2" has garnered both critical and audience acclaim, earning an impressive 91% audience rating and 93% critics rating on Rotten Tomatoes. American film critic Peter Travers remarked of the film: "No cinema buff should miss it... See [Eastwood's] 'Juror #2' and make his day."

### **AFM, NBCUniversal Settle Civil Action; Submit Your Incomplete Track Information**

NBCUniversal and the American Federation of Musicians are jointly requesting information, pursuant to a settlement agreement in the civil action AFM v. NBCUniversal Media, LLC et al., pertaining to incomplete tracks used in one of the following programs from March 1, 2020 through October 1, 2024 ("Claim Period"), in order to ensure proper payment for such use pursuant to the **Television Videotape Agreement:** 

- "The Tonight Show Starring Jimmy Fallon"
- "Late Night with Seth Meyers"
- "Saturday Night Live"
- "Today Show"
- "The Kelly Clarkson Show"

### Celebrate the Wins, Organize for the Future

Many of us in the Labor Movement knew that a Trump re-election would mean hard days ahead for the working people of the United States. During his first term, Trump spent four years in office weakening unions and working people while pushing tax giveaways to the wealthiest among us. He stacked the courts with judges who want to roll back our rights on the job. He made us less safe at work. He gave big corporations free rein to lower wages and make it harder for workers to stand together in a union. American Federation of Musicians International President Tino Gagliardi said the following in a statement released to members days following the November election (excerpted):

"We remain committed to actively defending our rights in the workplace and reinforcing the strength of our union together with the AFL-CIO and Canadian Labour Congress.

"I recognize that the AFM represents a diverse range of political views. However, it's important to reaffirm that our union will always stand in solidarity with those among us who experience hate of any kind. This includes the racism, anti-Semitism, Islamophobia, misogyny, homophobia, transphobia, and xenophobia so energetically enabled by the President-elect's campaign.

"While our strategies may shift, our goals will remain focused and unwavering. Together, we will persist in our advocacy efforts for musicians on both sides of the border and work towards a brighter future."

Despite the long road ahead, the Labor Movement does have several victories to celebrate in the wake of this historic election.

### **Celebrate the Wins**

One year ago, after the LA Fed hosted a Poverty and Homelessness Summit, the LA County labor movement pledged to address the poverty crisis. In the year since, the L.A. labor movement rolled up its sleeves, partnering with a coalition of housing experts, mental health professionals, labor leaders, and community advocates to find a long-term viable solution: Measure A. When voters passed Measure A, it served as a continuation of this legacy where we build communities where everyone – regardless of race, income, or zip code – has the chance to thrive. This measure will strengthen workers' voices in their workplaces, ensuring that they have the power to advocate for fair treatment, safe working conditions, and a seat at the table.

Additionally, the L.A. labor movement was successful


in flipping the last remaining Republican held district, sending labor-champion George Whitesides to Congress.

These victories are tangible evidence of the power of organizing and what we can achieve when we form people-power coalitions to tackle the issue of our day.

### **Organize for the Future**

So what's next? We continue to do what we always have done: work together to create meaningful change for the better. In the words of AFL-CIO President Liz Shuler: "Presidential administrations change, but the Labor Movement's values do not. We stand for the freedom to organize and for the right to collectively bargain. We stand for solidarity — the kind that is built when working people stand together to take on the biggest, richest bosses and the most powerful extremist politicians. Most importantly, we know how to fight back when anyone comes after our freedoms."

#### Quincy Jones Life Member. Conductor/Composer 3/14/1933 – 11/3/2024

Quincy Jones, the multi-talented music titan whose vast legacy ranged from producing Michael Jackson's historic "Thriller" album to writing prize-winning film and television scores and collaborating with Frank Sinatra, Ray Charles and hundreds of other recording artists, has died at 91.

A Life Member of AFM Local 47, Jones kept company with presidents and foreign leaders, movie stars and musicians, philanthropists and business leaders. He toured with Count Basie and Lionel Hampton, arranged records for Sinatra and Ella Fitzgerald, composed the soundtracks for "Roots" and "In the Heat of the Night," organized President Bill Clinton's first inaugural celebration and oversaw the all-star recording of "We Are the World," the 1985 charity record for famine relief in Africa.

<u>An outpouring of memories and tributes from</u> <u>around the world</u> have been shared since news of his death. He was laid to rest November 10 during a private ceremony in Los Angeles.

### **Dues Schedule**

Annual and Semi-Annual Membership Dues for Regular, Life and Inactive Life Members are due January 1 of each year. Payment must be received by March 31 (three-month grace period) to avoid suspension. If not paid by this date, a \$75 reinstatement fee will be assessed. Payment must be paid by June 30 to avoid expulsion.

Likewise, Semi-Annual Membership Dues for Regular Members are due **July 1** and must be received by **September 30** (three-month grace period) to avoid suspension. If not paid by this date, a \$75 reinstatement fee will be assessed. **Payment must be paid by December 31 to avoid expulsion.** 

Please note: Inactive Life Members do not have all of the same rights as privileges as Regular and Life Members, such as the right to vote in Local elections. Please review the AFM Local 47 Bylaws for complete information.

> Notice From the Executive Board: Work Dues Delinquency and Suspension

1) Local 47 members whose work dues delinquency exceeds \$500 shall be suspended; and

2) Non-Local 47 members whose work dues delinquency exceeds \$500 shall be referred to the IEB as provided in the AFM Bylaws.

In order to reinstate membership, a \$75 reinstatement fee will be assessed.

### **Resignation Policy**

In order to resign in good standing, you must submit your written request to Local 47 before your membership is suspended. Though dues are due Jan. 1 and July 1, current grace periods extend to March 31 and Sept. 30, respectively; suspensions are posted April 1 and Oct. 1.

In addition to membership dues, all other financial obligations, Local and International, must be paid prior to resignation. Your letter of resignation will be presented at the following Executive Board meeting and a written response will be mailed to you. If you wait, you will be required to pay another half year's dues and/or clearance fee.

### Multiple-Card AFM Member Rebate

Did you know? If you hold membership in three or more Locals throughout a full calendar year, you are entitled to a rebate from the AFM.

Under the rebate program, membership in a base of two Locals must be established in order for a member to qualify for a rebate. The International Secretary/ Treasurer's office has determined that a musician's membership in his or her "Home Local" and the subsequent Local of longest tenure shall be designated as the two base Locals. The Secretary/Treasurer's office will then rebate the appropriate per capita dues for membership in the third Local and any other Local(s) beyond three to which a member belonged for the entire previous calendar year.

To petition for a Multiple-Card Member Rebate, members should fill out the form and return it to the Secretary/Treasurer's office together with copies of all their paid-up membership cards, receipts of canceled checks for annual dues from all Locals, or a letter from each Local stating that the petitioner was a member in good standing of the Locals for the full year prior. Rebates will be issued after Jan. 1.
